# REQUEST FOR PROPOSALS (RFP) RFP/DPHSS-2018-007 Case Management Services (CMS)

The Department of Public Health and Social Services (DPHSS), Division of Senior Citizens (DSC), is requesting proposals from qualified Service Providers to provide Island-Wide professional Title III Case Management Services in keeping with Title III Older Americans Act of 1965 as amended, 45 CFR Chapter XIII, Subchapter C, Part 1321, the Administration for Community Living's program requirements and all the grant requirements applicable to subrecipients of federal funds set forth in 2 CFR Part 200, and 45 CFR Part 75, DPHSS, DSC State Plan on Aging and all applicable policies, requirements, handbooks and the laws and regulations of the government of Guam.
