

### **Alee I Catherine's Home: Women's Shelter**

#### **October 2017**

During the month of October 2017, the Alee I Catherine's Home of Family Violence Domestic Assault shelter received a total of three hundred and five (305) calls:

Fifteen (15) possible client referral calls from agencies, to include thirteen (13) self-referrals, one (1) VARO, and one (1) from the Public Defender Service Corporation. Two hundred nine (209) active clients inquiring/giving information, fifteen (15) past client inquiring/giving information, twenty (20) calls for active clients, fourteen (14) outside agency calls inquiring/giving information, fifteen (15) program/staff related calls, seven (7) calls for donations inquiry, three (3) wrong number calls, and seven (7) hang ups.

Alee I provided services for a total of eleven (11) clients for the month of October; six (6) new clients, and five (5) clients from the previous month.

#### **Active Clients for October 2017:**

Client #2338 Client entered the shelter on April 27, 2017 at 5:51pm with her three (3) minor children, ages four (4), eight (8), and twelve (12). Client is a forty-one (41) year old married Filipino woman who is residing on Guam with a Green Card. Upon entry, client brought her personal vehicle to the shelter which she utilized for transportation. Client was assisted with transportation pick-up and drop-off services to and from client's children's school. Client was assisted with applying for the *CCD of Block Grant* in by giving the client an application form. Client was in the process of applying for *CCD of Block Grant* services. Client was also assisted with referral services to *Sanctuary Inc.* and with the *Guam Department of Youth Affairs (DYA)* when client sought assistance for her children's behavioral issues. Client was assisted with baby-sitting and respite care services when client sought medical attention at the *Guam Regional Medical City (GRMC)*, which client was also assisted with transportation pick-up services to and from *GRMC*. Transportation services were also provided to client to a car dealership in an attempt for client to purchase another vehicle. In regards to housing, client was assisted with providing the *Guam Housing and Urban Renewal Authority (GHURA)- Public Housing Program* the proper documentation in order to boost client's status on the waiting list and with

applying for the *Salvation Army's Emergency Solutions Grant Program Homelessness Prevention and Rapid Re-Housing Program (ESG-HPRRP)*. Client was assisted with applying for and receiving a Protective Order. Referral services and accompaniment to the Protective Order hearing were provided. Client was evicted due to numerous incident reports of client's child disturbing the peace of the shelter as a result, causing fear for other clients. Client and child were counseled numerous times about behavior and given options on possible interventions before eviction resulted, however behavior did not change. Client transitioned to family, specifically her cousin, upon exit/ eviction on September 17, 2017 at 8:07pm.

Client #2352 Client entered the shelter on October 12, 2017 at 4:22pm with her minor children, ages, five (5) and six (6). Client is a twenty-three (23) year old single Palauan woman who is a U.S. citizen. Client was assisted with transportation pick-up and drop-off services to and from client's children's school. Client was assisted with submitting her Public Benefits change report to the *Department of Public Health and Social Services (DPHSS)* and with applying for Child Support with the *Office of the Attorney General- Child Support Division*. In regards to housing, client was assisted with applying with the *Guam Housing and Urban Renewal Authority (GHURA)- Public Housing Program*. Client applied for a Protective Order prior to entering the shelter and accompaniment to the Protective Order hearing was provided. Client was evicted due to violation of shelter rules which jeopardized the location of the shelter. Client transitioned to family upon exit/ eviction on October 19, 2017 at 10:29pm.

Upon intake, client decided that she would find family members to transition to. Client was assisted with transportation pick-up and drop-off services from the referring agency and to the designated drop-off point. Client transitioned to family upon exit on September 27, 2017 at 8:42pm.

Client #2193-2 Client entered the shelter on August 10, 2017 at 12:04am with her minor child, aged three (3) months. Client is a thirty-seven (37) year old single Hawaiian woman who is a U.S. citizen. During the month of December 2017, the Alee I Catherine's Home of Family Violence Domestic Assault shelter received a total of three hundred and five (305) calls:

Eighteen (18) possible client referral calls from agencies, to include thirteen (13) self-referrals, and five (5) VARO. One hundred and seventy-eight (178) active clients inquiring/giving information, nineteen (19) past clients inquiring/giving information, twenty-nine (29) calls for active clients, one (1) call for a past client, seventeen (17) outside agency calls inquiring/giving information, twenty-six (26) program/staff related calls, and seventeen (17) calls for donation inquiry,

Alee I provided services for a total of ten (10) clients for the month of December; two (2) new clients, and eight (8) clients from the previous month.

**Alee 2 Children's Home**

**October 2017**

For the Month of October the shelter served a total of twenty (20) children with ages ranging from two-months (2 months) to eleven (11). Of the children, there were five (5) Chuukese, twelve (12) Chamorro, two (2) Korean, and one (1) Filipino. Services provided included personal care, teaching life skills, transportation to and from school, visitations and various appointments as well as recreational activities.

On October 1, Social Worker (SW) received a phone call from Child Protective Services (CPS) caseworker R. Tomy in regards to the four (4) minors; ages eight (8), six (6), five (5), and three (3). SW was informed that minors would be transitioning out of the shelter and leaving for Chuuk with their mother. Alee staff assisted with transportation services and minors were brought to the airport where they met with CPS Caseworker R. Tomy and their mother.

On October 5, SW received a phone call from CPS Supervisor A. Gadia in regards to the two (2) minors ages six (6) and two (2). SW was informed that minors would be transitioning out of the shelter and back to parents.

On October 24, SW received a phone call from CPS caseworker W. Roduk in regards to the female minor six (6) years old at the shelter. SW was informed that minor would be transitioning out of the shelter and into a foster home. On October 24, transportation services were provided for the minor, where she was taken to CPS to meet with W. Roduk.

Currently at the shelter, there is one (1) Chuukese minor, eleven (11) Chamorro minors, and (1) Filipino minors.

For the male minor age seven (7), there were a total of four (4) visitations made for this month. All visitations took place at CPS with a homemaker present. As per CPS caseworker M. Kahele, visits will continue until further notice, as court ordered. On October 19, 2017 an appointment was made at I'Famagu'on-ta where the minor was assessed. Alee Children's SW was informed

that I'Famagu'on-ta would make contact within 2-3 weeks for a follow up. Minor entered the shelter on September 07, 2017 (54 days).

For another set of siblings, a total of two (2) overnight visits were made for this month. All overnight visitations took place with grandparents. As per CPS caseworker M. Blas, grandparents are still awaiting their voucher through the *Family Unification Program (FUP)*. On October 30, the male minor age eight (8) and female minor age six (6) were scheduled to meet with their care coordinator at *I Famagu'on-Ta* for a follow up. Minors were transported by Alee Staff, where they met with Elisa Duenas. Minors entered the shelter on January 1, 2017 (304 days)

For one set of siblings, there were a total of eighteen (18) visitations made for this month. Ten (10) visitations had taken place at Barrigada Park while the other eight (8) visitations took place at Erica's House. All visitations take place with mother and father but are separated and under the supervision of a CPS homemaker or a visitation monitor. As per CPS caseworker S. Quinata, the mother has found a housing unit through the *Family Unification Program (FUP)*. November 3<sup>rd</sup> has been set for her housing inspection and once passed, she will receive her keys. As per S. Quinata, if housing unit is granted to the mother, the siblings will begin with overnight furloughs. A court hearing will take place in November that will determine whether the children transition to the mother or continue with overnight furloughs. The siblings entered the shelter on November 28, 2016 (137 days).

For the male minor; twenty one (21) months, a total of four (4) visitations were made for this month. Three (3) visitations had taken place with minor's siblings at CPS while the other took place with minor's father at his residence all under the supervision of a CPS homemaker. On October 27<sup>th</sup>, the minor was transported to the Northern Region Community Health Center. Minor was seen by S. Tinio from *Project Bisita*, where she conducted a follow-up for his next screening.

For the female minor age five (5), a total of three (3) visitations were made for this month. All visitations had taken place at CPS with the mother under the supervision of a homemaker. On October 27<sup>th</sup>, minor was transported to Guam Memorial Hospital (GMH) due to throwing up blood, constant vomiting, and a high temperature. Tests were performed on the minor and results indicated positive for Influenza A (Flu). Minor was prescribed medication to take for the next five (5) days. Upon returning to the shelter, minor was isolated from the other children while gaining more rest. Minor was well and returned back to school on October 31<sup>st</sup>.

For another set of siblings, the male minor, twenty two (22) months was taken to Guam Memorial Hospital on October 25, 2017. Minor had suffered a seizure and medics were contacted immediately for urgent care. At the hospital, minor was prescribed *Motrin* for his fever and instructed to return if seizures continue.

### November 2017

For the Month of November, the shelter served a total of nineteen (19) children with ages ranging from two-months (2 months) to eleven (11). Of the children, there were seventeen (17) Chamorro, one (1) Chuukese, and one (1) Filipino. Services provided included personal care, teaching life skills, transportation to school, visitations and various appointments as well as recreational activities.

On November 07, the Alee Children's Shelter Social Worker (SW) received a phone call from Child Protective Services (CPS) in regards to the 8 yr. old male minor at the shelter. The SW was informed that the male minor would be transitioning out of the shelter and into a foster home. On November 08, transportation services were provided for the minor, by Alee Staff. Minor entered the shelter on September 17, 2017. (75 days)

On November 16, the SW received a phone call from CPS in regards to the four siblings (10yrs, 8yrs, 7yrs, and 6yrs). As per CPS caseworker S. Quinata, the four minors would not be returning back from furlough. Minors would be transitioning out of their shelter and back with their mother. Minors entered the shelter on November 29, 2016. (366 days)

On November 19, the SW received a phone call from CPS in regards to the female old minor (6yrs). SW was informed that the female minor would be transitioning back home with the mother. On November 20, the minor was transported to Child Protective Services, by Alee Staff. Minor entered the shelter on October 05, 2017. (56 days)

On November 21, the SW received a phone call from CPS regarding the male minor (3yrs) at the shelter. As per CPS caseworker R. Reyes, the minor would be transitioning out of the shelter and placed with relatives. Transportation services were provided by R. Reyes.

Currently at the shelter, there are twelve (12) Chamorro minors.

For one set of siblings, a total of five (5) overnight visits were made for this month. All overnight visitations took place with the grandparents. As per CPS caseworker M. Blas, grandparents are still awaiting their voucher through the *Family Unification Program (FUP)*. Minors entered the shelter on January 1, 2017 (334 days).

For one set of siblings, a total of five (5) visits were made for this month. All visitations had taken place in the Hagatna area, with the mother. On November 08, an appointment was made with American Medical Clinic in Upper Tumon to establish a primary pediatrician for the three minors. After seeing Dr. Fojas, a referral to *I'Famagu'onta* as well as a referral to see a neurologist was made for the 22-month old minor. As for the 5 year old minor, a referral to see an audiologist was made, due to not passing the hearing test. Minors were also given shots to update their immunization cards. On November 28, Charly Harper from *Guam Early Interventions System* conducted a home assessment at the shelter for the 22-month old minor. Physical exercises for the minor were discussed, in regards to his cerebral palsy. On November 30, an appointment was made with *Women, Infants and Children (WIC)* to have Alee staff as the authorized representative/proxy for the minors' benefits. As per CPS caseworker W. Roduk, mother is currently seeking housing. Minors entered the shelter on October 22, 2017 (39 days).

For the male minor (21 months), a total of twelve (12) visitations were made for this month. Four (4) visits had taken place with minor's siblings at CPS while the others were with the minor's father at CPS, all under the supervision of a CPS homemaker. On November 17, the Children's Shelter SW received a phone call from CPS in regards to placement for an 8yr old male minor (13 days). On November 29, an appointment to Client Services was made for the minor. On November 22, SW received a phone call from CPS in regards to placement for a 5yr old male minor (9 days). All male minors (21 months, 5yrs, and 8yrs) are siblings.

For the male minor (5yrs), appointments have been set with *I'Famagu'onta* as well as *IHP Medical Group* in regards to services. Minor entered the shelter on November 21, 2017 (10 days).

For the two female minors (7yrs and 2yrs), both were taken to the *Guam Police Department-Crime Lab* for forensic photos. Minors entered the shelter on November 29, 2017 (2 days).

- ❖ November 13, 2017: August 4, 2017: Melissa San Nicolas of the Department of Public Health and Social Services Bureau of Social Service Administration conducted the quarterly monitoring of the shelter. No issues/concerns were brought to our attention.
- ❖ November 21, 2017: Remeliza Oriondo of the Department of Public Health and Social Service Division of Environmental Health conducted its quarterly inspection of the shelter. Two concerns were brought to our attention; a small hairline crack in the window separating the kitchen and the dining room and two (2) weather strips that needed replacing. The shelter received an "A" rating.

**December 2017**

For the Month of December, the shelter served a total of eleven (11) children with ages ranging from four -months (4 months) to eleven (11). Of the children, there were ten (10) Chamorro and one (1) Filipino. Services provided included personal care, teaching life skills, transportation to school, visitations and various appointments as well as recreational activities.

Currently at the shelter, there are eleven (11) Chamorro minors and one (1) Filipino minor.

For one set of siblings, a total of ten (10) overnight visits were made for this month. All overnight visitations took place with the grandparents. As per Child Protective Services (CPS) caseworker S. Quinata, grandparents are currently seeking alternative housing options while still awaiting their voucher through the *Family Unification Program (FUP)*. Minors entered the shelter January 1, 2017 (365 days).

For one set of siblings, a total of eight (8) visitations were made for this month. Six (6) visitations had taken place in the Hagatna area while two (2) were made at the Tamuning Wendy's, with both parents. On December 08, a checkup for the four (4) month old infant was completed at the American Medical Clinic in Upper Tumon. On December 15 and 18, *Guam Early Intervention Systems (GEIS)* representative Charly Harper conducted a home assessment to observe the 2-year old minor who has cerebral palsy. *GEIS* will be conducting monthly home visits. As per CPS caseworker W. Roduk, Minors entered the shelter on October 22, 2017 (70 days).

For another set of siblings, a total twelve (12) visitations were made for this month. All visitations had taken place at the home of the grandparents. Transportation services and supervision were provided by CPS. On December 08, the nine (9) year old minor was taken to Guam Behavioral Health and Wellness Center (GBHWC) in order to be assessed for suicidal ideations and behavioral issues. Social Worker (SW) attempted to contact the assigned CPS caseworker, but was not able to reach her. Alee Children SW as well as Shelter Worker transported the minor to GBHWC where he was admitted. Treatment for the minor was discussed between the *Alee Shelter, Client Services, CPS, Guardian ad Litem, I'Famagu'on-ta,* and *GBHWC* prior to discharge. On December 14, minor was discharged from GBHWC and returned back into shelter. On December 20, an appointment to see a neurologist was made for the nine (9) year old minor which was recommended by GBHWC child psychiatrist. A total of three (3) appointments were made for the nine (9) year old minor with Client Services, specifically *Katherine Mafnas*. Minor entered the Shelter on November 17, 2017 (44days). On December 26, the 2 (2) year old male minor was taken to *Express Care* and treated for a splinter

in his foot. Other male minors entered the shelter on October 02 and November 22, 2017 (90/40 days).

For the six (6) year old male minor, as per CPS caseworker R. Reyes, there are no possible placements at this time. Minor entered the shelter on November 21, 2017 (41 days).

For the four (4) year old female minor, a total of one (1) visitation was made for this month. Visitation had taken place for two (2) hours at the offices of CPS with the mother, under the supervision of caseworker S. Olkeriil. Minor entered the shelter December 21, 2017 (11 days).


