REQUEST FOR PROPOSALS (RFP)
RFP/DPHSS-2018-006 Adult Day Care (ADC) Services Program

The Department of Public Health and Social Services (DPHSS), Division of Senior Citizens (DSC), is requesting proposals from qualified Service Providers to provide professional Title III Adult Day Care Services in keeping with Title III Older Americans Act of 1965 as amended, 45 CFR Chapter XIII, Subchapter C, Part 1321, the Administration for Community Living's program requirements and all the grant requirements applicable to subrecipients of federal funds set forth in 2 CFR Part 200, and 45 CFR Part 75, DPHSS, DSC State Plan on Aging and all applicable policies, requirements, handbooks and the laws and regulations of the government of Guam.

Project funding provided by the Prime Award from the United States Department of Health & Human Services, Administration for Community Living, Adult Day Care Services Program. Grant Document Number 18AAGUT3SS and Catalog of Federal Domestic Assistance (CFDA) Number 93.044 Title III-B under Title 45 Code of Federal Regulations, Part 92 and Sub Award passed through by the DPHSS, DSC and local government of Guam Funds.

RFP/DPHSS- 2018-006 ADULT DAY CARE (ADC) SERVICES PROGRAM

Contractor – Subawardee/Subrecipient will provide Title III compliant management and operations of Adult Day Care Services to approximately 119 individuals age 60 and older, on every service day, who have been determined to be functionally impaired and are at risk of institutionalization, and to provide respite services for families/caregivers of these individuals while the individual is attending one of the three (3) Adult Day Care centers. Adult Day Care/Adult Day Care Health provided in the nature of personal care for dependent elders in a supervised, protective, and congregate setting during some portion of a day to include social and recreational activities; training; counseling; and services such as rehabilitation, medications assistance and home health aide services for adult day care health.
