

## MEDICALLY INDIGENT PROGRAM (MIP) OFF-ISLAND REFERRAL

The Medically Indigent program (MIP) covers eligible recipients for necessary off-island medical services that are not available on island.

#### 1. OFF ISLAND REFERRAL PACKET:

- Off-Island Referral Form: To be completed by the referring physician and submitted with:
  - o Supporting medical records such as laboratory/pathology results, X-ray/CAT scan/MRI reports, consultation reports, EKG report, etc.
  - o If a Nurse Practitioner signs referral, a physician <u>MUST</u> co-sign referral.
- <u>MEDIF FORM:</u> To be completed by the attending/referring physician within 10 days of departure and signed by the physician and patient/authorized representative
  - o If oxygen is needed, **OXYGEN REQUEST FORM** (Guam to Honolulu & Guam to Manila) and **PHYSICIAN'S STATEMENT FOR POC** (Honolulu to U.S) must be attached.
- Other Health Insurance Documents: If the patient has a primary insurance (private insurance or Medicare).
  - Appointment Card
  - o Statement of Coverage
  - o Denial of Airfare with explanation (if not covered by primary insurance)

#### 2. REVIEW OF REFERRAL REQUEST:

The BHCFA Office will review the off-island referral for approval or denial:

- <u>Approved</u>: Medical records will be sent to an off-island provider for review and acceptance. As soon as the appointment is made, the client will be informed accordingly.
  - Arrangements will be made by the BHCFA Off Island Coordinator
- Other Insurance: The primary insurance carrier will make the initial arrangements with the provider for the appointment.

#### 3. LODGING AND GROUND TRANSPORTATION ARRANGEMENTS

Room and board, Lodging, and Food are the patient's responsibility.

I understand that off-island coverage is limited to \$175,000.00 which includes the airfare of the patie and medical escort per fiscal year, \$50,000.00 for orthopedic services and appliances which includes the airfare of the patient and medical escort per fiscal year, and responsible for any amount in excess of the maximum coverage.
I understand that I am responsible for 10% co-insurance on any cardiac related services, orthoped services and appliances, radiation therapy and radiology services.
I understand that I am <b>responsible for my liability</b> if I am under the <b>MIP with liability</b> .
I understand that <b>orthopedic appliances</b> , <b>to include orthopedic implants</b> , <b>are covered</b> .  The following services are <u>not</u> covered – palliative and/or experimental treatments, cardia valves/stents, pacemakers, AICD and the anticipated device:  Patient Initial:
I understand that in the event of death, cargo transportation service, casket, and mortuary/funer service are not covered.
I understand that roundtrip air travel is provided to an eligible patient. If the patient is a minor, one (1) pare and/or one (1) medical escort when medically necessary. Patient must return to Guam within the next datafter clearance from the specialist and/or hospital.
If I have a primary insurance, I understand that I am responsible in <b>obtaining necessary documents from my primary insurance</b> , regarding coverage, approval/denial of the off-island medical referral include appointments with the accepting off-island provider.
I understand that I am responsible for \$2.50 copayment for each prescribed medication and that Micovers generic medications only.
I understand that I must be FINANCIALLY READY for the cost of meals, ground transportation
lodging, outpatient medications and any exclusion of medical services and/or co-payment, co-insurances and deductibles.
I understand that I am responsible for <b>expenses incurred with non-participating medical providers.</b>
If approved, I shall <b>ensure to inform my eligibility specialist/caseworker that I will be going off-island for medical treatment</b> and that my <b>eligibility under the program is current and <u>valid for three months.</u></b>
