**Alee I Catherine's Home: Women's Shelter**

**October 2018**

During the month of October 2018, the Alee I Catherine's Home of Family Violence Domestic Assault shelter received a total of one hundred and ninety-one (191) calls:

Fifteen (15) possible client referral calls, to include ten (10) self-referrals, four (4) potential referrals from VARO and one (1) potential client referral from the GPD-DART. Ninety-four (94) active clients inquiring/giving information, seven (7) past clients inquiring/giving information, thirty-one (31) calls for active clients, one (1) call for past clients, three (3) outside agency calls inquiring/giving information, twenty-eight (28) program/staff related calls, two (2) calls for donations inquiry and three (3) wrong numbers.

Alee I provided services for a total of eleven (11) clients for the month of October two (2) new clients, and nine (9) clients from the previous month.
