Alee I Catherine's Home: Women's Shelter

April 2019

During the month of April 2019, the Alee I received one hundred eighty-six (186) calls:

Twenty-seven (27) possible client referral calls, to include fifteen (15) self-referrals, nine (9) potential referrals from VARO, one (1) from the GLS-DLC, one (1) from Public Defender Service Corporation and one (1) from Sagua Managu. Ninety-two (92) active clients inquiring/giving information, thirty-one (31) calls for active clients, one (1) past client inquiring/giving information, five (5) calls for past clients, seventeen (17) outside agency calls inquiring/giving information, eight (8) program/staff related calls, three (3) donation calls and two (2) hang ups.

Alee I provided services for a total of ten (10) clients for the month of April: three (3) new clients, and seven (7) clients from the previous month.

Active Clients for April 2019:

Client #2411 entered the shelter on April 03, 2019 at 7:04pm with her three (3) minor children, age five (5), one (1), and three (3) months old. The client is a thirty-three (33) year old, single female, Palauan and a U.S. Citizen. The client is a victim of intimate partner/domestic violence-specifically that of physical and emotional abuse by her common law, whom she was living with prior to entering shelter. Client was referred by Victim Advocates Reaching Out (VARO). Client was assisted with transportation services for pick-up at one of our shelter designated locations.

Client was assisted with shelter stay, meals, transportation and toiletries services. Client was assisted with transportation services to Department of Public Health Vital Statistics in Mangilao to obtain youngest child's birth certificate. Client was also transported to Social Security Office in Tiyan to apply for youngest child's social security card. Client was referred to Child Protective Agency for her oldest child, due to educational neglect. In regard to her housing, client had applied for Guam Housing Urban Renewal and Authority Section 8 Program and Public Housing prior to entering the shelter and was provided a VOR (Verification of residence). Client did not want assistance in applying for a protective order. Client exited the shelter on April 08, 2019 at 09:10am. It is unknown where the client transitioned to, since client did not come back to the shelter after curfew. Client was in the shelter for five (5) days.

Client #2412 entered the shelter on April 09, 2019 at 8:20pm with her three (3) minor children, ages seven (7), four (4), and nine (9) months old. The client is a twenty-four (24) year old, single female, Chamorro and a U.S. Citizen. The client is a victim of intimate partner/domestic violence-specifically that of physical and emotional abuse by her boyfriend, whom she was living with prior to entering shelter. Client was referred by a family member. Client was assisted with transportation services for pick-up and drop off at one of our shelter designated locations. Client was assisted with shelter stay, meals, clothing, transportation and toiletries services. Client son was given school supplies and bag pack. Client did not want assistance in applying for a protective order. Client exited the shelter on April 11, 2019 at 08:36am. Client transitioned to family. Client was in the shelter for two (2) days.

Client #2410 entered the shelter on March 25, 2019 at 3:57pm with her two (2) minor children, ages four (4), and six (6) months old. On April 2, 2019 client brought her two other children ages three (3) and two (2) years old to the shelter. The client is a twenty-five (25) year old, single female, Chuukese and a FSM Citizen. The client is a victim of intimate partner/domestic violence-specifically that of physical and emotional abuse by her ex-boyfriend, whom she was living with prior to entering shelter. Client was referred by Victim Advocates Reaching Out (VARO). Client was assisted with transportation services for pick-up and drop off at one of our shelter designated locations. Client was assisted with shelter stay, meals, clothing, transportation and toiletries services. Client was assisted with transportation services to Department of Public Health and Social Services (DPHSS) Supplemental Nutritional and Assistance Program (SNAP) and Woman, Infants, and Children (WIC) Program. Client was also transported to Guam Housing and Urban Renewal Authority (GHURA) in Sinajana, Guam Regional Medical City (GRMC), and Guam Memorial Hospital (GMH). In regards to her housing, client had applied for Guam Housing Urban and Renewal Authority prior to entering the shelter and was provided a Letter of Continued Interest to submit. Client was not sure if she wants assistance in applying for

a protective order. Client exited the shelter on April 13, 2019 at 11:56pm. It is unknown where the client transitioned to, since client did not come back to the shelter after curfew. Client was in the shelter for nineteen (19) days.

Client #2413 entered the shelter on April 18, 2019 at 8:40pm by herself. The client is a thirty-four (34) year old, married female, Filipina and a U.S. Citizen. The client is a victim of intimate partner/domestic violence-specifically that of emotional abuse by her husband, whom she was living with prior to entering shelter. Client was referred by Victim Advocates Reaching Out (VARO). Client was assisted with transportation services for pick-up at one of our shelter designated locations. Client was assisted with shelter stay, meals, clothing, transportation and toiletries services. Client brought her POV in the shelter on April 19, 2019 after having the tire fixed. Client exited the shelter on April 20, 2019 at 11:10pm with her POV. Client transitioned to a friend. Client was in the shelter for two (2) days.

Client #2362 Client entered the shelter on January 16, 2018 at 6:29pm with her one (1) child, age two (2) year old. Client is a thirty-two (32) year old, single Chuukese female, who is a FSM citizen. The client is a victim of intimate partner/domestic violence-specifically that of physical and emotional abuse by her boyfriend, whom she was living with prior to entering shelter. Client was assisted with applying and obtaining her son's social security card at the Social Security Office. Client was also assisted with applying and submitting her application for Public Benefits with the Department of Public Health and Social Services (DPHSS). Client was assisted with transportation services for dental appointment, grocery shopping at Payless Supermarket and Cost U-Less, to Department of Public Health and Social Services (DPHSS) Supplemental Nutritional and Assistance Program (SNAP) and to Woman, Infants, and Children (WIC) Program, and to GHURA AMP4. Client was also transported to the Department of Public Health and Social Services (DPHSS) Supplemental Nutritional and Assistance Program (SNAP) for recertification and GHURA in Sinajana for continued interest. Client was assisted with a longdistance phone call to get an update on her personal document. Client also applied for GHURA Section 8 Program and was selected for the lottery. Client recently applied for the Online Pre-Application for GHURA AMP4. Client was assisted with her application for Salvation Army's Emergency Solutions Grant and Homelessness Prevention and Rapid Re-Housing Program (ESG-HPRRP). Client is currently seeking assistance from Guam Legal Services to apply for protective order. Client is an active client and been in the shelter for four hundred and sixtyseven (467) days.

Client #2178-1 Client entered the shelter on March 19, 2018 at 12:23pm with her five (5) minor children, ages one (1), three (3), four (4), six (6), and eight (8) years old. Client was able to get her other twin child, age one (1) year old, back from her family member and is now in the

client's care. Client is a thirty (30) year old single Chuukese female, who is an FSM citizen. The client is a victim of intimate partner/domestic violence-specifically that of physical and emotional abuse by her boyfriend, whom she was living with prior to entering shelter. Client was assisted with transportation services to take her children to and from school, to Department of Public Health and Social Services (DPHSS), Woman, Infants, and Children (WIC) Program to follow up on her public benefits, to GHURA in Sinajana for continued interest. Client was also assisted with transportation to the Dededo Precinct and for grocery shopping at Payless Supermarket and Cost U-Less, Micronesian Legal Center in Harmon Industrial, Harmon Loop Dental, Guam Regional Medical City (GRMC) and Mega Drug Store for her medication. Client was provided with an application for the Head Start Program for her children who were eligible for the program and was provided transportation to International Health Partners (IHP) Medical Group for the PPD skin testing. Client was transported to and from CPK (California Pizza Kitchen) to participate in her daughter's fieldtrip for school. Client was assisted in scheduling an appointment with U.S. Citizenship and Immigration Services to obtain a copy of her I-94. In regards to her housing, client was assisted in applying for Guam Housing and Urban Renewal Authority (GHURA) and was transported to GHURA in Sinajana for continued interest. Client also applied for GHURA Section 8 Program and was selected for the lottery. Client was assisted with applying for the Salvation Army's Emergency Solutions Grant and Homelessness Prevention and Rapid Re-Housing Program (ESG-HPRRP). Client has a protective order. Client is an active client and been in the shelter for four hundred and seven (407) days.

Client #2294-1 Client entered the shelter on November 25, 2018 at 4:57pm with her two (2) minor children: eight (8) years old and seven (7). Client is a thirty-two (32) year old, single Chamorro female, who is a U.S. Citizen. The client is a victim of intimate partner/domestic violence-specifically that of physical and emotional abuse by her boyfriend, whom she was living with prior to entering shelter. Client was assisted with transportation services for her children's school pick up and drops off. Client was also assisted with transportation for grocery shopping at Payless Supermarket and Cost U-Less, Department of Public Health and Social Services (DPHSS), Salvation Army in Tiyan, Guam Power Authority, and GHURA office. In regards to her housing, client had applied for Guam Housing Urban and Renewal Authority prior to entering the shelter. Client received her Section 8 voucher on January 25, 2019 and asked for extension. Client Section 8 voucher extended to April 25, 2019 and client have set up appointment with future landlord to schedule a meeting with GHURA which was completed on April 25, 2019 with the signing of the contract. Salvation Army inspection was conducted on May 2, 2019. Client was provided an application for the Salvation Army's Emergency Solutions Grant and Homelessness Prevention and Rapid Re-Housing Program (ESG-HPRRP). Client has employment lined up; however there are pending documents that need to be submitted. Client

was assisted with obtaining the proper documents for her employment, but did not follow through. Client wanted assistance with applying for a protective order and child support from the Guam Legal Services (GLS). Client is an active client and been in the shelter for one hundred and fifty-six (156) days.

Client #2397-1 Client entered the shelter on December 12, 2018 at 11:00am. Client is a twenty-three (23) year old pregnant, single Korean female, who is a U.S. Citizen. The client is a victim of sexual assault by her boyfriend's friend, whom she was living with prior to entering shelter. Client was assisted with shelter stay, meals, toiletries, and transportation services. Client was assisted with transportation services to Department of Public Health and Social Services, Women's Health Clinic, Woman, Infants, and Children (WIC) Program, Express Drugstore and for grocery shopping to Payless Supermarket. Client was also assisted with transportation to Guam Behavioral Health & Wellness Center (GBHWC), Department of Public Health and Social Services (DPHSS) in Mangilao, Attorney General in ITC, and Guam Housing Urban and Renewal Authority (GHURA). In regards to her housing, client was provided an application for the Salvation Army Emergency Solutions Grant-Homelessness Prevention Rapid Re-Housing Program (ESG-HPRRP). Client was assisted with applying for the Online Pre-Application for Guam Housing Urban and Renewal Authority (GHURA) AMP4. Client wanted assistance in applying for a protective order and was able to obtain the protective order. Client is an active client and been in the shelter for ninety (90) days.

Client #2404 Client entered the shelter on February 08, 2019 at 10:32pm with her minor child, age four (4) months old. Client is a twenty-one (21) year old, single Chamorro female, who is a U.S. Citizen. Client was assisted with transportation services for pick up at one of our shelter designated locations. Client was assisted with shelter stay, meals, toiletries, and transportation services. Client was assisted with transportation services to Department of Public Health and Social Service, Guam Memorial Hospital (GMH), Woman, Infants, and Children (WIC) Program and Pay-Less Supermarket. In regards to her housing, client was given an application for Salvation Army Emergency Solutions Grant-Homelessness Prevention Rapid Re-Housing Program (ESG-HPRRP). Client was also assisted with applying for public benefits and WIC (Women, Infant, and Children). Client is an active client and been in the shelter for eighty-one (81) days.

Client #2152-1 Client entered the shelter on February 13, 2019 at 5:51pm with her five (5) minor children, ages eleven (11), ten (10), six (6), four (4) and one (1). Client is a forty (40) year old, married Palauan female, who is a citizen of the Republic of Palau. The client is a victim of intimate partner/domestic violence-specifically that of physical and emotional abuse by her husband, whom she was living with prior to entering shelter. Client was assisted with shelter

stay, meals, toiletries, clothing, and transportation services. Client was assisted with transportation services for pick up at one of our shelter designated locations. Client was also assisted with transportation to Department of Public Health and Social Services, Guam Legal Services, Micronesian Legal Services in Agana, Harmon Loop Dental, Attorney General in ITC and Mega Drugs. Client was transported for shopping at Cost U Less and Pay-Less Supermarket. Client attended the Parent Workshop in Yigo and was transported there and picked up. Client was also assisted with applying for public benefits and WIC (Women, Infant, and Children). Client withdrew the assistance of obtaining a new passport with client's married name with the Micronesian Resource Center. Client was assisted in enrolling her child into elementary school. Client's two (2) older children aged eleven (11) and ten (10) were transferred to the same school as the six (6) year old on March 11, 2019. In regards to her housing, client was assisted with applying for the Online Pre-Application for Guam Housing Urban and Renewal Authority (GHURA) AMP3 and AMP4. Client's perpetrator is currently incarcerated. Client is an active client and been in the shelter for seventy-six (76) days.

May 2019

During the month of May 2019, the Alee I received one hundred forty-two (142) calls:

Thirty-seven (37) possible client referral calls, to include eleven (11) self-referrals, twenty-two (22) potential referrals from VARO, two (2) from the Office of the Attorney General, and two (2) from the Probation Office. Twenty-eight (28) active clients inquiring/giving information, thirty-two (32) calls for active clients, nine (9) past clients inquiring/giving information, one (1) call for a past client, sixteen (16) outside agency calls inquiring/giving information, seven (7) program/staff related calls, ten (10) donation calls and two (2) wrong numbers.

Alee I provided services for a total of nine (9) clients for the month of May three (3) new clients, and six (6) clients from the previous month.

Client was assisted with transportation services for her children's school pick up and drops off. Client was also assisted with transportation for grocery shopping at Payless Supermarket and Cost U-Less, Department of Public Health and Social Services (DPHSS), Salvation Army in Tiyan, Guam Power Authority, and GHURA office. In

regards to her housing, client had applied for Guam Housing Urban and Renewal Authority prior to entering the shelter. The client is twenty-eight (28) year old, single Chamorro female, who is a U.S. Citizen. The client is a victim of intimate partner/domestic violence-specifically that of emotional abuse by her ex-boyfriend, whom she was living with prior to entering shelter. Client was self-referred. Client was assisted with transportation services for pick-up and drop off at one of our shelter designated locations. Client was assisted with shelter stay, transportation and toiletries services. Client did not want assistance in applying for a protective order. Client was evicted due to violating one of the shelter's rules and transitioned out on May 02, 2019 at 1:25pm. Client transitioned back to her perpetrator with her two minor children. Client was in the shelter for one (1) day.

Client #2404 Client entered the shelter on February 08, 2019 at 10:32pm with her minor child, age five (5) months old. Client is a twenty-one (21) year old, single Chamorro female, who is a U.S. Citizen. Client was assisted with transportation services for pick up at one of our shelter designated locations. Client was assisted with shelter stay, meals, toiletries, and transportation services. Client was assisted with transportation services to Department of Public Health and Social Service, Guam Memorial Hospital (GMH), Woman, Infants, and Children (WIC) Program and Pay-Less Supermarket. In regards to her housing, client was given an application for Salvation Army Emergency Solutions Grant-Homelessness Prevention Rapid Re-Housing Program (ESG-HPRRP). Client was also assisted with applying for public benefits and WIC (Women, Infant, and Children). Client was evicted due to violating one of the shelter's rules and

transitioned out on May 12, 2019 at 1:46am. It is unknown where the client transitioned to. Client was in the shelter for ninety-three (93) days.

Client was assisted with transportation services for pick up and drops off at one of our shelters designated locations. Client was assisted with shelter stay, meals, toiletries, clothing, and transportation services. Client was also assisted with transportation services to Guam Housing Urban and Renewal Authority (GHURA) in Sinajana to follow up on her public housing with a Notice of Continued Interest submission in Sinajana office, Social Security in Tiyan, and to Guam Judiciary Court in Agana. Alee 2 Children's Home

Services provided included personal care, teaching life skills, transportation to and from school, visitations and various appointments, as well as recreational activities.

Client #132-2017: For the seven (7) year old male minor, there was a total of one (1) visitation made for this month. Visitation took place at Child Protective Service building, under the supervision of a homemaker for one hour with his siblings. Minor attended a dental appointment at Dr. Ko Dental Clinic on March 05, 2019 for follow-up cleaning and exam. Minor needs further procedures done. Minor was referred to I'Famaguonta for counseling services. Minor was brought to GBHWC for CIU intake after hours due to having multiple behavior issues on April 04 2019. Minor transitioned to CPS on April 08, 2019 due to having explosive behavior tantrums. CPS had potential placement for the minor to go off-island but placement fell through. CPS had no other potential placement for the minor. Minor entered the shelter on November 21, 2017 (503 days).

Client #154-2018-1: For the eleven (11) year old male minor, there was a total of one (1) visitation at Client Services with his other siblings. Minor completed his dental appointment at Hafa Adai Dental on March 8, 2019 for examination and cleaning. Minor was brought to

GBHWC for CIU intake after hours due to having an explosive behavior tantrum. Minor transitioned to CPS on April 06, 2019 due to having explosive behavior tantrums. Minor entered the shelter on September 28, 2018 (190 days).

Client #170-2019: For the one (1) week old male infant, there were no scheduled visitations. Baby was seen at American Medical Center on April 16, 2019 for his immunizations and for rash on his bottom. Received a phone call from CPS Social Worker Moki that placement was found for the infant. Minor completed the x-ray on February 13, 2019 and ultrasound on February 22, 2019. Shelter Social Worker did not receive any update from Shriners for the minor. Shelter Social Worker has a scheduled meeting with IEP Coordinator, Monique, on May 3, 2019. For the 5-year-old minor, he went to AMC in Upper Tumon on March 25, 2019 for having an eye irritation. Dr. Del Rosario assessed the minor's eye and was red due to a virus and/or irritation. Minor was seen at Hafa Adai Dental on April 05, 2019 for examination and cleaning. For the 4year-old minor, he went to Hafa Adai Dental on March 01, 2019 for examination and cleaning. The 1-year-old minor entered shelter with completed immunizations and is awaiting documents

to enroll in block grant and daycare. Minor completed re-certification on March 07, 2019 with WIC. Minors entered the shelter on August 16, 2018 / August 16, 2018 / December 11, 2018 / February 07, 2019 (257 days / 257 days / 140 days / 82 days).

Client #142-2018-1: For the eleven (11) year old male minor, a total of two (2) visitations were made for this month out of two (2) scheduled visitations. Visitation took place with his mother and other siblings at Child Protective Services, under the supervision of a homemaker for one (1) hour. Alee Shelter Social Worker received update from Guam Shriners that the minor was anticipated to leave for Honolulu for treatment in June or July, but due to insufficient staffing from CPS, the minor would have to wait for another minor to get back with a CPS homemaker. Alee shelter social worker met with SPED Coordinator Monique R. to sign permission for evaluation. Minor starts summer school from June 11-July 16, 2019 from 7:45am to 12:00pm. For the 5-year-old minor, he was promoted to Kindergarten and will continue to attend the same school for FY: 2019-2020. For the 4-year-old minor, he will continue to be in Head Start for SY: 2019-2020 and will remain in the same class and school. Alee Social Worker renewed the minor's (including the 1-year-old) benefits for WIC for three (3) months. Re-certification is scheduled for August 8, 2019. For the 1-year-old minor, there are no documents provided to the Alee Social Worker for enrollment to

Block Grant and Daycare. Minors entered the shelter on August 16, 2018 / August 16, 2018 / December 11, 2018 / February 07, 2019 (288 days / 288 days / 171 days / 113 days).

Client #142-2018-1: For the eleven (11) year old male minor, a total of two (2) visitations were made for this month out of three (3) scheduled visitations. Visitation took place with his mother and other siblings at Child Protective Services, under the supervision of a CPS homemaker for one (1) hour. The minor was promoted to the next grade level for his elementary school. Minor starts summer school from June 11-July 16, 2019 from 7:45am to 12:00pm. Minor entered the shelter on October 14, 2018 (229 days).

Client #165-2018: For the nine (9) year old male minor, there was a total of two (2) visitations made for this month that took place at *Guam Behavioral Health and Wellness Center* with his mother and under the supervision of the CPS Social Worker. The minor had a total of three (3) counseling sessions at I'Famaguonta. Minor also did four (4) days of outing with his auntie on the weekend. Alee Social Worker attended at WRAP meeting for the minor that included his CPS Social Worker, I'Famaguonta Social Worker, and his school staff. The meeting discussed possible transition with his auntie mid to ending June 2019. The minor will continue to go on weekend outings and eventually have overnight stays to easily transition out. The minor is going to be held back from school and will remain in the 4th grade for SY: 2019-2020. Minor starts summer school from June 11-July 16, 2019 from 7:45am to 12:00pm. Minor entered the shelter on October 29, 2018 (214 days).

Client #120-2017-1: For the three (3) year old male minor, there were a total of three (3) visitations made for this month out of three (3) scheduled visitations. Visitations took place with his mother at Dededo Park, under the supervision of a CPS homemaker. Minor also attended five (5) family counseling sessions at Latte Treatment Center with his parents and siblings. Minor continues to attend daycare Monday to Friday. Minor entered the shelter on January 07, 2019 (144 days).

Client #119-2017-1: For the nine (9) year old male minor, a total of two (2) visitation was made for the month out of five (5) scheduled visitations. All visitations took place at Barrigada Park with siblings and mother under the supervision of a CPS homemaker. The minor had three (3) appointments with Client Services. The minor was seen at Hafa Adai Dental on May 10, 2019 for examination and cleaning. Minor starts summer school from June 11-July 16, 2019 from 7:45am to 12:00pm. Minor was seen at GBHWC with Dr. Ismael for follow-up appointment. Minor entered the shelter on March 5, 2019 (87 days).

Client #168-2019: For the nine (9) year old male minor, there were no scheduled visitations for this month. Minor was seen at Hafa Adai Dental on May 10, 2019 for examination and cleaning. Minor was promoted to the next grade level but will be enrolled into a new school for SY: 2019-2020. Minor entered the shelter on March 27, 2019 (65 days).

Client #169-2019: For the seven (7) year old male minor, there were no scheduled visitations for this month. Minor was seen at Dr. Ko's dental clinic on May 07, 2019 for examination and cleaning. Minor was not able to get any procedures done due to not having additional medical insurance. Minor does not qualify for Medicaid insurance since he is not a U.S. citizen. Minor has MIP for medical/dental insurance. Minor was also seen on May 13, 2019 at AMC Mangilao with Dr. Del Rosario to establish new patient care. Minor was ordered for a PPD skin test. Minor returned to AMC Upper Tumon on May 16, 2019 and results displayed that he was a positive reactor. Minor was referred for chest x-ray and was seen on May 23, 2019. Results came back and minor has clearance to return to school and no signs of lung inflammation. CPS Social Worker Moki brought minor to I'Famaguonta for intake and assessment on May 09, 2019. Minor starts summer school from June 11-July 16, 2019 from 7:45am to 12:00pm. Minor entered the shelter on April 11, 2019 (50 days).

Client #171-2019: For the five (5) year old male minor, there were a total of three (3) visitations made for this month at CPS under the supervision of a homemaker and one of the sibling's foster home. Minor was seen at Hafa Adai Dental on May 10, 2019 for examination and cleaning. Minor was seen at I'Famaguonta on May 23, 2019 for intake and processing. Minor entered the shelter on April 20, 2019 (41 days).

Client #173-2019: For the thirteen (13) year old male minor, there were no visitations made for this month. Minor was promoted to the seventh (7th) grade and will continue to attend his current school for SY: 2019-2020. Minor will be referred to I'Famaguonta for intake and assessment. Minor will be scheduled for dental appointment. Minor was registered for summer school by CPS Social Worker Craig M. Minor starts summer school from June 11-July 16, 2019 from 8:30am to 12:00pm.

June 2019

For the month of June, the shelter served a total of twelve (12) children with ages ranging from one (1) year old to thirteen (13) years of age. Of the children, there were eight (8) Chamorro, three (3) Chuukese, one (1) Filipino. Services provided included personal care, teaching life

skills, transportation to and from school, visitations and various appointments, as well as recreational activities.

For the 6-year-old minor, there was no update from Shriners and DOE SPED. Minor continues to attend summer school until July 16, 2019. For the 5-year-old minor, he is scheduled for standing shots at Mangilao Public Health on July 30, 2019 at 9:00am. For the 4-year-old minor, he is scheduled for standing shots at Mangilao Public Health on July 30, 2019 at 9:30am. For the 1-year-old minor, all documents are received for block grant; however, the minor needs to be scheduled for a physical. Minor would also need to be enrolled with Medicaid by CPS. Minors entered the shelter on August 16, 2018 / August 16, 2018 / December 11, 2018 / February 07, 2019 (318 days / 318 days / 201 days / 143 days).

Client #142-2018-1: For the eleven (11) year old male minor, a total of two (2) visitations were made for this month out of two (2) scheduled visitations. Visitation took place with his mother and other siblings at Child Protective Services, under the supervision of a CPS homemaker for one (1) hour. Minor had an appointment with Dr. Ismael on June 17, 2019 at 2:00pm. Minor continues to attend summer school Monday to Friday. Minor entered the shelter on October 14, 2018 (259 days).

Client #165-2018: For the nine (9) year old male minor, there was a total of two (2) visitations made for this month that took place at *Guam Behavioral Health and Wellness Center* with his mother and under the supervision of the CPS Social Worker. The minor had a total of two (2) counseling sessions at I'Famaguonta. Minor also did two (2) days of outing with his auntie on the weekend and three (3) weekend furloughs. Minor is anticipated to transition to family member on July 17, 2019. Minor entered the shelter on October 29, 2018 (244 days).

Client #120-2017-1: For the three (3) year old male minor, there were a total of four (4) visitations made for this month out of four (4) scheduled visitations. Visitations took place with his mother and siblings at Dededo Park, under the supervision of a CPS homemaker. Minor also attended four (4) family counseling sessions at Latte Treatment Center with his parents and

siblings. Minor continues to attend daycare Monday to Friday. Minor entered the shelter on January 07, 2019 (174 days).

Client #119-2017-1: For the nine (9) year old male minor, a total of two (2) visitations were made for the month out of four (4) scheduled visitations. All visitations took place at Barrigada Park with siblings and mother under the supervision of a CPS homemaker. Two (2) visitations were made with the siblings at the Harvest playground under the supervision of CPS homemaker. Minor went on two (2) outings with potential foster family. The minor had two (2) appointments with Client Services. Minor continues to attend summer school Monday to Friday. Minor entered the shelter on March 5, 2019 (117 days).

Client #168-2019: For the nine (9) year old male minor, there were no scheduled visitations for this month. Minor completed his annual physical on June 25, 2019 at AMC Mangilao. Minor is scheduled for a PPD skin test on July 25, 2019 at 8:45am at the Dededo Public Health. Minor was placed on the waiting list for summer school. Minor entered the shelter on March 27, 2019 (95 days).

Client #169-2019: For the seven (7) year old male minor, there were no scheduled visitations for this month. Minor would have to be seen at Mangilao Public Health as a walk-in for dental emergency. Minor has not been seen for examination and cleaning, due to not having sufficient health/dental insurance. Minor had a scheduled hearing test on June 19, 2019 at Guam Hearing Doctors. Minor entered the shelter on April 11, 2019 (80 days).

Client #171-2019: For the five (5) year old male minor, there were a total of four (4) visitations made for this month at CPS under the supervision of a homemaker.
