

Alee I Catherine's Home- Women's Shelter

October 2019

During the month of October 2019, the Alee I received two hundred and sixty-one (261) calls:

Twenty-four (24) possible client referral calls, to include sixteen (16) self-referrals, and eight (8) potential referrals from VARO. One hundred and ninety-one (191) active clients inquiring/giving information, eighteen (18) calls for active clients, three (3) past client inquiring/giving information, one (1) call for past clients, thirteen (13) outside agency calls inquiring/giving information, eight (8) program/staff related calls, and three (3) donation call.

Alee I provided services for a total of thirteen (13) clients for the month of October five (5) new client, and eight (8) clients from the previous month.

Alee I provided three hundred and ninety-three (393) meals and one hundred and seventy-six (176) transports to the clients at the shelter

(Client #2427): Client entered the shelter on September 24, 2019 at 5:35pm with her three (3) minor children ages: ten (10) year old, seven (7) year old and one (1) month old. Client is thirty-two (32) year old, married Chuukese female, who is a FSM Citizen. The client is a victim of intimate partner/domestic violence-specifically that of physical and emotional abuse by her husband, whom she was living with prior to entering shelter. Client was self-referred. The incident was not reported to the *Guam Police Department (GPD)*. Client was assisted with transportation services for pick up and drop off at one of our shelter designated locations. Client was assisted with shelter stay, meals, transportation and toiletries. Client was assisted with transportation services to take her children to and from school. Client was assisted in obtaining her SNAP card at the *Department of Public Health and Social Services (DPHSS) Supplemental Nutritional and Assistance Program* in Mangilao. In regards to her housing, client already applied for *Guam Housing and Urban Renewal Authority (GHURA) AMP#1 and AMP#3* upon entry into the shelter. Client also applied for *GHURA Section 8 Program* and was selected for the lottery. Client was provided an application for the *Salvation Army Emergency Solutions Grant-Homelessness Prevention Rapid Re-Housing Program (ESG-HPRRP)*. Client was given *Block Grant* application for child care. Client wanted assistance in applying for a protective order and was referred to *Guam Legal Services Corporation (GLS)*. Client exited the shelter with her three (3) minor children on October 02, 2019 at 10:51am. Client transitioned to a family member. Client was in the shelter for eight (8) days.

(Client #2419): Client entered the shelter on July 05, 2019 at 5:43pm by herself. Client brought her three (3) minor children ages: thirteen (13) year old, three (3) year old and one (1) year old in July 12, 2019. Client also brought her oldest child age fifteen (15) year old in July 16, 2019. Client is thirty-five (35) year old, married Chamorro female, who is a U.S. Citizen. The client is a victim of intimate partner/domestic violence-specifically that of physical and emotional abuse by her husband, whom she was living with prior to entering shelter. Client was referred by *Victim Advocates Reaching Out (VARO)*. The incident was not reported to the *Guam Police Department (GPD)*. Client does not want assistance in applying for a protective order. Client was escorted to the shelter by staff and brought her POV with authorization letter from her family member. Client was assisted with shelter stay, meals, clothing and toiletries services. Client was assisted with *Woman, Infants, and Children (WIC) Program* and *Department of Public Health and Social Services (DPHSS) Supplemental Nutritional and Assistance Program (SNAP and Welfare)* and *Salvation Army Food Commodity*. In regards to her housing, client was assisted in applying for the Online Pre-Application for *Guam Housing and Urban Renewal Authority (GHURA) AMP#4* and submitted all required documents. Client was also assisted and provided an application for the *Salvation Army Emergency Solutions Grant-Homelessness Prevention Rapid Re-Housing Program (ESG-HPRRP)* and turned in all required documents. Client declined the assistance of *Salvation Army Emergency Solutions Grant-Homelessness Prevention Rapid Re-Housing Program (ESG-HPRRP)* after she was informed that she will have to be employed full-time after the temporary assistance ends. Client exited the shelter with her three (3) minor children on October 14, 2019 at 8:23pm. Client transitioned back to her husband. Client was in the shelter for one hundred and one (101) days.

(Client #2426): Client entered the shelter on September 23, 2019 at 7:05pm by herself. Client was able to bring her one (1) minor child age two (2) year old at the shelter on September 28, 2019. Client is twenty-eight (28) year old, married Japanese female, who is a Japan Citizen. The client is a victim of intimate partner/domestic violence-specifically that of physical and emotional abuse by her husband, whom she was living with prior to entering shelter. Client was referred by *Guam Legal Services Corporation (GLS)*. Client was assisted with transportation services for pick up and drop off at one of our shelter designated locations. Client was assisted with shelter stay, meals, clothing, transportation, toiletries and respite care for her child. Client was assisted, transported and accompanied to the *Guam Police Department (GPD)* in Dededo to report the incident. Client was also transported to *GPD* in Tumon and in Hagatna precinct and was escorted to her residence to find her daughter. Client was referred to the *Domestic Assault Response Team (DART)* to assist and escort client in retrieving her personal belonging. Client

was transported to Western Union and for a recreational event in Barrigada. Client was also transported to DNA building to see a U.S. Immigration Attorney in regard to her status, to the *Superior Court* in Hagatna for her court hearing and to the *Department of Public Health and Social Services (DPHSS) Office of Vital Statistics* to obtain a copy of her child's Birth Certificate. Client wanted assistance in applying for a protective order and was referred to *Guam Legal Services Corporation (GLS)* in Anigua. Client was transported and accompanied to *GLS* to apply for Protective Order, divorce and child custody. Client was able to obtain a temporary protective order on October 02, 2019 for her and her minor child. A copy of her Protective Order is in her file. Client exited the shelter with her one (1) minor child on October 16, 2019 at 6:10pm. Client transitioned to her parents. Client was in the shelter for twenty-three (23) days.

(Client #2397-1): Client entered the shelter on January 02, 2019 at 2:35pm. Client is twenty-four (24) year old, single Korean female, who is a U.S. Citizen. The client is a victim of sexual assault by her boyfriend's friend, whom she was living with prior to entering shelter. Client was referred by *Victim Advocates Reaching Out (VARO)*. The incident was reported to the *Guam Police Department (GPD)*. Client was assisted with shelter stay, meals, toiletries, clothing and transportation services. Client was assisted with transportation services to *Department of Public Health and Social Services, Women's Health Clinic, Woman, Infants, and Children (WIC) Program, Express Drugstore*, for grocery shopping to *Payless Supermarket* and to a recreational event in Barrigada. Client was also assisted with transportation to *Guam Behavioral Health & Wellness Center (GBHWC)*, *Department of Public Health and Social Services (DPHSS)* in Mangilao, *Attorney General in ITC*, *American Job Center* in Anigua and *Guam Housing Urban and Renewal Authority (GHURA)*. In regards to her housing, client was provided an application for the *Salvation Army Emergency Solutions Grant-Homelessness Prevention Rapid Re-Housing Program (ESG-HPRRP)*. Client was assisted with applying for the Online Pre-Application for *Guam Housing Urban and Renewal Authority (GHURA) AMP#4* and was placed on the waiting list for Public Housing. Client had the baby on June 28, 2019 at *Sagua* and made the decision to give her son for adoption. Client completed her counseling session at *Guam Behavioral Health & Wellness Center (GBHWC)*. Client is currently an active volunteer in a non-profit organization. Client was interested in obtaining her GED diploma and was referred to *Guam Community College* to be assessed. Client was also interested in obtaining a job and was referred to the *American Job Center* in Anigua. Client wanted assistance in applying for a protective order and was able to obtain the protective order on January 29, 2019 effective through January 22, 2024. Client exited the shelter on October 18, 2019 at 1:15pm. Client transitioned to a family from her church. Client was in the shelter for two hundred and eighty-nine (289) days.

(Client #2428): Client entered the shelter on September 27, 2019 at 9:04am with her two (2) minor children ages: fourteen (14) and twelve (12) years old. Client is forty-one (41) year old, single Chamorro female, who is a U.S. Citizen. The client is a victim of family violence- specifically that of emotional abuse by a family member, whom she was living with prior to entering shelter. Client was referred by *Victim Advocates Reaching Out (VARO)*. The incident was not reported to the *Guam Police Department (GPD)*. Client was assisted with transportation services for pick up and drop off at one of our shelter designated locations. Client was assisted with shelter stay, meals, transportation and toiletries services. Client was assisted with transportation services to doctor's appointment at *FHP and Department of Public Health and Social Services (DPHSS) in Dededo, Guam Housing and Urban Renewal Authority (GHURA) AMP#4* to drop off documents and to do grocery shopping at *Pay-Less Supermarket*. Client was also transported to *Public Health in Mangilao* and laundry mart. In regards to her housing, client already applied for the Online Pre-Application for *Guam Housing and Urban Renewal Authority (GHURA) AMP#4* upon entry into the shelter. Client does not want assistance in applying for a protective order. Client was evicted due to violating one of the shelter's rules and transitioned out with her two (2) minor children on October 19, 2019 at 6:35pm. It is unknown where client transitioned to. Client was in the shelter for twenty-two (22) days.

(Client #2425): Client entered the shelter on September 12, 2019 at 11:50am with her one (1) minor child age four (4) year old. Client brought her other minor child age seventeen (17) year old on September 14, 2019. Client is forty-four (44) year old, married Filipina female, who is a U.S. Citizen. The client is a victim of intimate partner/domestic violence- specifically that of physical and emotional abuse by her husband, whom she was living with prior to entering shelter. Client was referred by *Victim Advocates Reaching Out (VARO)*. Client was escorted to the shelter by staff and brought her own POV and provided registration for her car. Client was assisted with shelter stay, meals, transportation and toiletries services. Client was transported and accompanied to the *Guam Police Department (GPD)* to report the incident. In regards to her housing, client was assisted in applying for the Online Pre-Application for *Guam Housing and Urban Renewal Authority (GHURA) AMP#4*. Client was provided an application for the *Salvation Army Emergency Solutions Grant-Homelessness Prevention Rapid Re-Housing Program (ESG-HPRRP)* and was accompanied during the intake process. Client turned in all required documents. Client wanted assistance in applying for a protective order and was referred to *Guam Legal Services Corporation (GLS)*. Client was transported and accompanied to *Guam Legal Services Corporation (GLS)* to apply for the protective order, divorce and child custody. Client received a Temporary Order of Protection and a copy is in her file. Client is employed

full-time. Client volunteered to exit the shelter on October 25, 2019 at 5:30pm. Client transitioned to a friend. Client was in the shelter for forty-three (43) days.

Active clients for October 2019:

(Client #2178-1): Client entered the shelter on March 19, 2018 at 12:23pm with her six (6) minor children ages: eight (8) year old, six (6) year old, five (5) year old, three (3) year old, and two (2) year old twins. Client is thirty (30) year old, single Chuukese female, who is a FSM Citizen. The client is a victim of intimate partner/domestic violence-specifically that of physical and emotional abuse by her boyfriend, whom she was living with prior to entering shelter. Client was referred by *Salvation Army*. The incident was not reported to the *Guam Police Department (GPD)*. Client was assisted with transportation services for pick up and drop off at one of our shelter designated locations. Client was assisted with shelter stay, meals, clothing, toiletries, transportation services and respite care for her children. Client was assisted with transportation services to take her children to and from school, to *Department of Public Health and Social Services (DPHSS)* in *Dededo* and *Mangilao*, *Woman, Infants, and Children (WIC) Program* to drop off documents. Client was also assisted with transportation to the *Guam Police Department Dededo Precinct* and to *Payless Supermarket* and *Cost U-Less* for grocery shopping, *Micronesian Legal Center* in *Harmon Industrial*, *Harmon Loop Dental*, *Guam Regional Medical City (GRMC)*, *Guam Behavioral Health and Wellness Center (GBHWC)*, *Attorney General Office (AG) for Child Support*, *Catholic Social Service* for back to school, *Dededo Mayor's Office*, *Mega Drug Store* for her medication and to a recreational event in *Barrigada*. Client was provided with an application for the *Head Start Program* for her children who were eligible for the program and was provided transportation to *International Health Partners (IHP) Medical Group* for the *PPD skin testing*. Client was transported to *CPK (California Pizza Kitchen)*, to the *University of Guam Agriculture Department*, and to the *Governor's House* in *Hagatna* to participate in her daughter's fieldtrip for head start. Client was assisted in scheduling an appointment with *U.S. Citizenship and Immigration Services* to obtain a copy of her *I-94*. Client received her *I-94* March 15, 2019 a copy was made on June 13, 2019 and placed in her file. In regards to her housing, client was assisted in applying for *Guam Housing and Urban Renewal Authority (GHURA)* and was transported to *GHURA* in *Sinajana* for continued interest and in *Yona* for her orientation. Client also applied for *GHURA Section 8 Program* and was selected for the lottery. Two of her older children were enrolled for the no cost summer camp program in June 11, 2019 until August 14, 2019. Client's fourth child has been enrolled for head start and was selected for school year 2019/20. Client filed for *Child Support* in 2017 with *GLS* and follow-up on August 2019 was informed to open an account with *Bank of Guam*. Client is

currently on the waiting list for GHURA public housing and has turned in all documents required. Client was assisted with applying for the *Salvation Army's Emergency Solutions Grant and Homelessness Prevention and Rapid Re-Housing Program (ESG-HPRRP)* and was accompanied to Tiyan to submit her application. Client was given eleven (11) days to turn in all required documents which she has completed on September 11, 2019. Client has a protective order. **Client is an active client and has been in the shelter for five hundred and ninety-one (591) days.**

(Client #2152-1): Client entered the shelter on February 13, 2019 at 5:51pm with her six (6) minor children ages: twelve (12) year old, ten (10) year old, six (6) year old, four (4) year old, two (2) year old and nineteen (19) days old. Client is forty- one (41) year old, separated Palauan female, who is a Republic of Palau Citizen. The client is a victim of intimate partner/domestic violence-specifically that of physical and emotional abuse by her husband, whom she was living with prior to entering shelter. Client was referred by *Victim Advocates Reaching Out (VARO)*. The incident was reported to the *Guam Police Department (GPD)*. Client was assisted with transportation services for pick up and drop off at one of our shelter designated locations. Client was assisted with shelter stay, meals, toiletries, clothing, transportation services and respite care for her children. Client was also assisted with transportation to *Palau Consulate in ITC* to pick up client's passport and to apply for her two oldest children's passport, *Catholic Social Service* for back to school supply, *Police Record in ITC* to obtain a Police Clearance, *Department of Public Health and Social Services (DPHSS)* in Dededo and in Mangilao *Office of Vital Statistics* for her youngest child's Birth Certificate, *Guam Legal Services Corporation, Micronesian Legal Services in Agana, Harmon Loop Dental, Attorney General in ITC, Western Union, 17 Minute Photo, Northern Court* and *Mega Drugs*. Client was transported for shopping at *Cost U Less* and *Pay-Less Supermarket*. Client attended the Parent Workshop in Yigo and was transported there and picked up. Client was also assisted with applying for public benefits for *WIC (Women, Infant, and Children)*. Client was assisted in enrolling her child into elementary school. Client's two (2) older children aged twelve (12) and ten (10) were transferred to the same school as the six (6) year old on March 11, 2019. Three of her older children started summer camp on June 3, 2019 until August 14, 2019. Client enrolled fourth child in Head Start and was accepted into the program for school year 2019/20. Client was assisted and transported to obtain her passport photo for her I-94 application. Client was assisted by *Micronesian Resource Center* to obtain her I-94 through the *U.S. Citizenship & Immigration Services*. Client received her I-94 on October 17, 2019. Client was transported to *Guam Memorial Hospital (GMH)* and had her daughter on October 12, 2019. Client was transported to *Social Security Office* in Tiyan to apply for her

youngest child's Social Security Card, In regards to her housing, client was assisted with applying for the Online Pre-Application for *Guam Housing Urban and Renewal Authority (GHURA) AMP#3 and AMP#4*. Client is currently gathering all required documents to turn in for *(GHURA)*. Client's perpetrator was incarcerated and released on May 29, 2019. Client wanted assistance in applying for a protective order and was able to obtain the protective order. **Client is an active client and has been in the shelter for two hundred and sixty (260) days.**

(Client #2078-3): Client entered the shelter on October 10, 2019 at 11:02am with her three (3) minor children ages: ten (10) year old, eight (8) year old and five (5) year old. The client is a thirty-one (31) year old, married Chamorro female, who is a U.S. Citizen. The client is a victim of intimate partner/domestic violence-specifically that of emotional abuse by her husband, whom she was living with prior to entering shelter. Client was referred by *Victim Advocates Reaching Out (VARO)*. The incident was not reported to the *Guam Police Department (GPD)*. Client did not want assistance in applying for a protective order. Client was assisted with transportation services for pick-up and drop-off at one of our shelter designated locations. Client was assisted with shelter stay, meals, transportation and toiletries services. Client was also assisted with transportation services to take her children to and from school, and also to designated shelter location for drop off. **Client is an active client and has been in the shelter for twenty-one (21) days.**

Client filed for Child Support in 2017 with *GLS* and follow-up on August 2019 was informed to open an account with Bank of Guam. Client was assisted with applying for the *Salvation Army's Emergency Solutions Grant and Homelessness Prevention and Rapid Re-Housing Program (ESG-HPRRP)* and was accompanied to *Tiyan* to submit her completed application. Client completed all required documents on September 11, 2019. Client was provided job applications and Child Care for the *DPHSS- Work Program*. Client exited the shelter with her six (6) children on December 31, 2019 at 11:11am. Client transitioned out to her Mother. Client was in the shelter for six hundred and fifty-two (652) days.

Client was assisted with shelter stay, meals, clothing, toiletries, transportation services and respite care for her children. Client was assisted with transportation services to take her children to and from school, to *Department of Public Health and Social Services (DPHSS)SNAP-Program*, to *Catholic Social Service* for the Toys for Tots on December. In regards to her housing, client was provided *Salvation Army's Emergency Solutions Grant and Homelessness Prevention and Rapid Re-Housing Program (ESG-HPRRP)* application. Client exited the shelter with her five (5) children on December 31, 2019 at 2:30pm. Client transitioned out to a friend's home. Client was in the shelter for eighteen (18) days.

Client was assisted with shelter stay, meals, clothing, toiletries services, and respite care for her children. Client was transported to the In regards to her housing, Client was receiving Section 8 voucher prior to entering the shelter and gave it up due to non-payment of her share of the rent. Client wanted assistance in applying for a protective order and was referred to *Guam Legal Services Corporation (GLS)*. Client was transported, and accompanied to *GLS* in Anigua. **Client is an active client and has been in the shelter for one (1) day.**

Alee II Children's Home

October 2019

Minor went on one (1) weekend outing with his family members. Minor also went on one (1) weekend furloughs with the same family members. Minor entered the shelter on October 29, 2018 (361 days) and exited on October 25, 2019. Minor transitioned to his grandmother.
