Alee I Catherine's Home- Women's Shelter

January 2020

(Client #2441)- Client entered the shelter on January 03, 2020 at 3:48pm with her daughter. Client is fifty-one (51) year old, married Chamorro female, who is a U.S. Citizen. The client is not a victim of intimate partner/domestic violence-specifically that of physical and emotional abuse prior to entering shelter. Client insisted that her daughter is the victim not her. Client was self-referred. The incident involved her daughter and was reported to the *Guam Police Department (GPD)* in Hagatna Precinct. Client was assisted with transportation services for pick up and drop off at one of our shelter designated locations. Client was assisted with shelter stay and transportation services. Client exited the shelter with her daughter, whom was a victim of Domestic Violence. Client declined to be separated from her daughter who was offered to stay at the shelter. Client was referred to Guma San Jose but her daughter contacted her sibling instead. Client exited on the same day January 03, 2020 at 4:42pm. Client transitioned to her son. Client was in the shelter for one (1) day.

(Client #2442)- Client entered the shelter on January 03, 2020 at 3:48pm with her Mother. Client is nineteen (19) year old, single Chamorro female, who is a U.S. Citizen. The client is a victim of intimate partner/domestic violence-specifically that of physical and emotional abuse by her ex-girlfriend whom she was living with prior to entering shelter. Client was self-referred. The incident was reported to the *Guam Police Department (GPD)* in Hagatna Precinct. Client was assisted with transportation services for pick up and drop off at one of our shelter designated locations. Client was assisted with shelter stay and transportation services. Client exited the shelter with her Mother, who after assessment was not a victim of DV or FV. Client declined to stay in the shelter without her Mother. Client was referred to Guma San Jose but called her sibling instead. Client exited on the same day January 03, 2020 at 4:44pm after contacting her brother. Client transitioned to her brother. Client was in the shelter for one (1) day.

Client is thirty- eight (38) year old, single Chamorro female, who is a U.S. Citizen. The client is a victim of intimate partner/domestic violence-specifically that of physical and emotional abuse by her boyfriend, whom she was living with prior to entering shelter. Client was referred by *Victim Advocates Reaching Out (VARO)*. The incident was reported to *Guam Police Department (GPD)* at Sheraton Hotel in Tamuning. Client was assisted with transportation services for pick up and drop off at one of our shelter designated locations. Client was assisted with shelter stay, meals, toiletries, transportation services and respite care for her child. Client was assisted with transportation services to take her to *Guam Legal Services Corporation (GLS)* to pick up her Protective Order and to the *Guam Judiciary Center* for her court hearing. In regards to her housing, Client was receiving Section 8 Voucher prior to entering the shelter and gave it up due to non-payment of her share of the rent. Client wanted assistance in applying for a Protective Order and was referred to *Guam Legal Services Corporation (GLS)* in Hagatna. Client was transported and accompanied to *GLS* to file for Protective Order. Client was able to obtain the Protective Order and a photocopy is in her file. Client exited on January 07, 2020 at 5:04pm with her one (1) minor child. Client transitioned to her mother. Client was in the shelter for eight (8) days.

The client is a twenty-nine (29) year old, single Chamorro female, who is a U.S. Citizen. The client is a victim of intimate partner/domestic violence-specifically that of physical and emotional abuse by her boyfriend, whom she was living with prior to entering shelter. Client was referred by *Victim Advocates Reaching Out (VARO)*. The incident was not reported to the *Guam Police Department (GPD)*. Client was assisted with transportation services for pick-up and drop-off at one of our shelter designated locations. Client was assisted with shelter stay, meals, toiletries, transportation services and respite care for her children. Client was assisted with transportation services to take her children to and from school, to *Department of Public Health & Social Services: SNAP Program* in Dededo to obtain a new EBT Card, to *Payless Supermarket* for grocery shopping, and to *Guam Housing Urban and Renewal Authority (GHURA) AMP#2* in Yona to submit a Change Report. In regards to her housing, client applied for the Online Pre-Application for *GHURA AMP#2 and AMP#4* prior to entering the shelter. Client filed for a Protective Order on November 15, 2019 and a copy of her Temporary Protective Order is in her file. Client exited the shelter with her five (5) minor children on

January 12, 2020 at 3:30pm. Client transitioned to her sister. Client was in the shelter for six (6) days.

(Client #2443)- Client entered the shelter on January 11, 2020 at 12:15am with her three (3) minor children ages, fifteen (15) year old, twelve (12) year old, and eleven (11) year old. Client is forty-one (41) year old, single Chuukese female, who is a FSM Citizen. The client's two minor daughters are the victim of sexual assault by a male relative, whom she was living with prior to entering shelter. Client was referred by *Guam Police Department (GPD)*. The incident was reported to the *Guam Police Department (GPD)* in Hagatna Precinct. Client was assisted with transportation services for pick up and drop off at one of our shelters designated locations. Client was assisted with shelter stay, meals, toiletries, clothing and transportation services. Upon further assessment, Client did not meet criteria and was referred to *Victim Advocates Reaching Out (VARO)* and exited on January 11, 2020 at 1:50pm with her three (3) minor children. Client transitioned to *VARO*. Client was in the shelter for one (1) day.

(Client #2381-1)- Client entered the shelter on January 17, 2020 at 12:50pm by herself. The client is twenty-seven (27) years of age, single Filipino female, who is a U.S Citizen. Client was assisted with transportation services to take her children to and from school, to *Palau Consulate in ITC* to pick up her updated passport and to submit her divorced decree, to the *Department of Public Health and Social Services (DPHSS)* in Dededo for *WIC*, to *Coast 360*, to *Benavente Middle School* to pick up school verification, to *Dededo Mayor's Office*, to *Department of Motor Vehicle (DMV)* to obtain her Guam Identification Card. Client was also transported for shopping at *Cost U Less* and *Pay-Less Supermarket*, to *Micronesian Resources Center* to pick up I-94 applications for her two older children. Client was referred to *ISA Psychological Services Center* for counseling and was also assisted with transportation. In regards to her housing, client was assisted with applying for the Online Pre-Application for *Guam Housing Urban and Renewal Authority (GHURA) AMP#3 and AMP#4*. Client submitted all required documents to *GHURA* in Agat on January 27, 2020. Client's perpetrator was incarcerated and released on May 29, 2019. Client wanted assistance in applying for a Protective Order and was referred to *Guam Legal Services Corporation (GLS)* in Hagatna. Client was able to obtain the Protective Order and a photocopy is in her file. Client is an active client and has been in the shelter for three hundred and fifty-two (352) days.

(Client #2436): Client entered the shelter on November 21, 2019 at 7:05pm by herself. Client is thirty- one (31) year old, single Palauan female, who is a U.S. Citizen. The client is a victim of intimate partner/domestic violence-specifically that of physical and emotional abuse by her boyfriend, whom she was living with prior to entering shelter. Client was self-referred. The incident was not reported to *Guam Police Department (GPD)*. Client was escorted to the shelter by staff and brought her own POV and provided registration for her car. Client was assisted with shelter stay, meals, clothing, and toiletries services. In regards to her housing, Client was given an application for the *Salvation Army's Emergency Solutions Grant and Homelessness*

Prevention and Rapid Re-Housing Program (ESG-HPRRP) and was assisted in submitting the completed application in Tiyan. Client was referred by *Victim Advocates Reaching Out (VARO)*. The incident was reported to *Guam Police Department (GPD)* in Dededo Precinct after the Client entered the shelter. Client was assisted with transportation services for pick up and drop off at one of our shelter designated locations. Client was assisted with shelter stay, meals, clothing, toiletries, transportation services and respite care for her children. Client was assisted with transportation services to take her children to and from school, to the *Department of Public Health and Social Services (DPHSS) SNAP Program* for a Change Report and pick up a new EBT Card, to Head Start in Tiyan to withdraw and enroll her daughter to another school, to *GPD* in Dededo to file harassment against her husband, to *Coast 360*, to the *Guam Judiciary Center* for her court hearing, to *Guam Legal Services Corporation (GLS)* for her divorce, and to *Catholic Social Service Thrift Store*. Client was also transported to *Pay-Less Supermarket* for grocery shopping and to *ERICA'S House* for supervised visitation. In regards to her housing, Client applied for *Guam Housing Urban and Renewal Authority (GHURA) AMP#1* prior to entering the shelter and transported to submit the Change Report in Toto. Client wanted assistance in applying for a Protective Order and was referred to *Guam Legal Services Corporation (GLS)* in Hagatna. Client was transported and accompanied to *GLS* to file for Protective Order. Client was able to obtain the Protective Order and a photocopy is in her file. Client is an active client and has been in the shelter for forty-seven (47) days.

(Client #2345-1): Client entered the shelter on January 23, 2020 at 5:27pm with her four (4) minor children ages, sixteen (16) year old, thirteen (13) year old, eleven (11) year old and eight (8) year old. Client is forty-six (46) year old, married Marshallese female, who is a Republic of Marshall Islands Citizen. The client is a victim of intimate partner/domestic violence-specifically that of physical and emotional abuse by her husband, whom she was living with prior to entering shelter. Client was self-referred. The incident was reported to the *Guam Police Department (GPD)* at a relative's house in Yigo. Client was assisted with transportation services for pick up

and drop off at one of our shelters designated locations. Client was assisted with shelter stay, meals, toiletries, clothing, school supplies and transportation services. Client was assisted with transportation services to take her children to and from school, and to a doctor's clinic for a PPD reading. In regards to her housing, Client applied for *Guam Housing Urban and Renewal Authority (GHURA) AMP#1* prior to entering the shelter. The incident involved one of her oldest son's and was not reported to the *Guam Police Department (GPD)*. Client was assisted with transportation services for pick up and drop off at one of our shelter designated locations. Client was assisted with shelter stay, meals, toiletries, and transportation services. Client was assisted with transportation to the *Department of Youth Affairs* in Mangilao. Client did not meet criteria and exited the shelter with her five (5) minor children and was referred to *Victim Advocates Reaching Out (VARO)*. Client exited on February 09, 2020 at 8:55am. Client was in the shelter for two (2) days.

The client is a victim of intimate partner/domestic violence-specifically that of physical and emotional abuse by her husband, whom she was living with prior to entering shelter. Visitation took place at CPS Building for one (1) hour under the supervision of CPS Homemaker. Visitation is with siblings. CPS scheduled a visitation on January 3, 2020 with potential foster parents. Minor went on weekend furlough following the visitation. Minor went to Public Health WIC for enrollment on January 8, 2020. Minor entered the shelter on October 4, 2019 (105 days). CPS found foster placement for the minor. Minor exited on January 17, 2020 and transitioned to foster parents.

(Client #120-2017-1)- For the four (4) year old male minor, there were a total of two (2) visitations made for this month out of two (2) scheduled visitations. Visitations took place with his mother, father, and siblings at the parents' residence, under the supervision of a CPS homemaker. Minor will be aging out of the WIC program this month. For the 2-year-old minor, there were no scheduled medical appointments for the month and no medical concerns. The minor was seen at WIC for a mid-certification appointment on January 09, 202. The 5-year-old minor and 2-year-old minor have attended four (4) foster outings. CPS has potential placement for the 5-year-old and 2-year-old siblings and have been going on weekend outings with fosters. **Minors entered the shelter on August 16, 2018 / December 11, 2018 / February 07, 2019 (533 days / 416 days / 358 days).**

(Client #119-2017-1): For the ten (10) year old male minor, there were no visitations made for the month out of three (3) scheduled visitations. There were no medical appointments this month and no medical concerns. CPS has not found placement for the minor. **Minor entered the shelter on March 5, 2019 (332 days).**

(Client #183-2020)- For the 10-year-old female minor there was one (1) missed visitation this month out of one (1) scheduled visitation. There were no medical or dental appointments this month, and no medical concerns. Minor transitioned to relative on February 13, 2020. The minor entered the shelter on January 17, 2020 (27 days).

(Client #181-2019/ #182-2019)- For another set of siblings, a five (5) year old female minor and a three (3) year old male minor had a total of one (1) visitation out of three (3) scheduled visitations made for this month. (Client #168-2019): For the nine (9) year old male minor, there were a total of four (4) scheduled visitations for this month. Visitation takes place with minor's siblings at Dededo Park under the supervision of CPS Homemaker for one (1) hour. Two (2) additional visitations were made during the month for visitation with parents. There were no medical appointments this month and no medical concerns. Minor goes on weekend furloughs with a relative. CPS is

planning to place the minor with a relative. **Minor entered the shelter on March 27, 2019 (339 days).**

(Client #174-2019 / #177-2019): For another set of siblings, a six (6) year old male minor and a four (4) year old female minor, there were a total of four (4) visitations made out of four (4) scheduled visitations. Visitations were held at *Erica's House* for two (2) hours with a relative. For the six (6) year old male minor, he was seen at *American Medical Center* for a muscle spasm on February 11, 2020. Doctor recommended close monitoring and liquids. Minor was seen on February 21, 2020 at *Hafa Adai Dental* for an exam and cleaning. For the four (4) year old female minor, she was seen at *Public Health* on February 05, 2020 for lead testing required for Head Start. Minor was seen at *Hafa Adai Dental* on February 07, 2020 for an exam and cleaning. Minor would need prior authorization for filling. There were no medical appointments this month and no medical concerns. Minor attends Head Start half-day in the morning and half-day at daycare in the afternoon. CPS has not found placement for the minors. **Minors entered the shelter on July 24, 2019 / August 09, 2019 (220 days / 204 days).**

(Client #184-2020): For the one (1) year old male minor, there were no scheduled visitations for this month. CPS added one (1) visitation that took place at CPS with parents. Minor was seen at *American Medical Center* for coughing and wheezing. He was prescribed Amoxicillin, Neb machine, and Albuterol. Minor was seen at *American Medical Center* on February 14, 2020 for a follow-up appointment. **Minor entered the shelter on January 25, 2020 (35 days).**

(Client #186-2020): For the thirteen (13) year old female minor, there were no scheduled visitations for this month. Minor started school on February 13, 2020. The minor had no medical or dental appointments this month, and no medical concerns. Minor received services from *Healing Hearts* for intake and multidisciplinary team interview on February 18, 2020. Minor began receiving services from Client Services for this month. **Minor entered the shelter on February 09, 2020 (21 days).**

(Client #187-2020 / #188-2020 / #189-2020): For a set of female siblings, (13-year-old minor, 6-year-old minor, and 2-year-old minor) there were two (2) visitations made out of two (2) scheduled visitations. For both visits, the 13-year-old minor refused to attend. For the thirteen (13) year old minor, she attends school. Minor has an upcoming dental appointment for a filling. There were no medical appointments made and no medical concerns. For the six (6) year old minor, she is also attending school. The minor went to *GBHWC* for a psychiatric evaluation on February 19, 2020. There were no medical appointments made and no medical concerns. For the two (2) year old minor, she is a recipient of block grant and currently attends daycare full-time. Minor has an upcoming WIC appointment. There were no medical appointments made and no medical concerns. **Minors entered the shelter on February 14, 2020 (16 days) / February 21, 2020 (9 days)**

March 2020

For the month of March, the shelter served a total of twelve (12) children with ages ranging from one (1) year old to thirteen (13) years of age. Of the children, there were eight (8) Chamorro and four (4) Chuukese. Services provided included personal care, teaching life skills, transportation to and from school, visitations and various appointments, as well as recreational activities.

(Client #189-2020)- For the thirteen (13) year old female minor, there were no visitations made out of two (2) scheduled visitations. Minor refused to go to visitations. Visitations scheduled from March 16-31st were canceled due to the outbreak of COVID-19. Minor was seen at *Harmon Loop Dental* for a filling on March 4, 2020. Due to the minor being uncooperative, the dental clinic scheduled her for another appointment on March 23, 2020 for bottom filling. There were no medical appointments made and no medical concerns. Minor was seen at client services on March 9, 2020 for one (1) hour. Minor was taken to GBHWC for intake on March 11, 2020. Minor transitioned to alternative placement on March 12, 2020. Minor entered the shelter on February 21, 2020 (21 days)

Currently at the shelter, there are eight (8) Chamorro Minors and four (4) Chuukese Minors:

(Client #159-2018 / #166-2018 / #167-2019): For a set of male siblings, (6-year-old minor, 5-year-old minor, and 2-year-old minor) there were no visitations made for this month out of eight (8) scheduled visitations. Visitations were canceled due to parents not being able to make it. Visitations scheduled from March 16-31st were canceled due to the outbreak of COVID-19. For the 6-year-old minor, there were no dental appointments made for the month. For the 6-year old minor, he was seen at *American Medical Center* on March 31, 2020, for diarrhea and throwing up. Doctor recommended a soft liquid diet, to stay hydrated, and did not prescribe any medication. The 5-year old minor had no medical or dental appointments made for the month. For the 2-year-old minor, there were also no medical or dental appointments made for the month. Minor had a scheduled WIC appointment on March 25, 2020, but it was canceled due to the government shutdown. It will be rescheduled soon. The 5-year-old and 2-year-old minors have attended one (1) weekend furlough with potential foster parents. The 5-year-old minor and 2-year-old minor have also received phone calls from potential foster parents. CPS has potential placement for the 5-year-old and 2-year-old siblings with fosters. **Minors entered the shelter on August 16, 2018 / December 11, 2018 / February 07, 2019 (593 days / 476 days / 418 days).**

(Client #119-2017-1): For the ten (10) year old male minor, the minor has no visitations with mother until further notice. For client services, the minor made two (2) visitations out of four (4) scheduled visitations for one (1) hour. Two (2) visitations were canceled due to the outbreak of COVID-19. Minor was seen at *American Medical Center* on March 5, 2020 for a rash. Doctor prescribed 2% hydrocortisone and 2% ketoconazole cream. The minor has been displaying

concerning behaviors for a few weeks within the month. The client will be receiving intervention services through I'Fanguon'ta. CPS has not found placement for the minor. **Minor entered the shelter on March 5, 2019 (392 days).**

(Client #168-2019): For the ten (10) year old male minor, there was one (1) visitation made out of four (4) scheduled visitations for this month. Visitation takes place with minor's siblings at Dededo Park under the supervision of CPS Homemaker for one (1) hour. Visitations scheduled from March 16-31st were canceled due to the outbreak of COVID-19. There were no dental or medical appointments this month and no medical concerns. Minor goes on weekend furloughs with a relative. Minor has been on furlough with relative, since March 13, 2020 and has not returned due to the outbreak of COVID-19. CPS is planning to place the minor with a relative. **Minor entered the shelter on March 27, 2019 (370 days).**

(Client #174-2019 / #177-2019): For another set of siblings, a six (6) year old male minor and a four (4) year old female minor, there was one (1) visitation made out of four (4) scheduled visitations. Visitations were held at *Erica's House* for two (2) hours with parents. Visitations scheduled from March 16-31st were canceled due to the outbreak of COVID-19. For the six (6) year old male minor, he was seen at *American Medical Center* for updated immunizations on March 9, 2020. For the four (4) year old female minor, she was seen at *American Medical Center* for a medical clearance for a dental procedure, on March 2, 2020. Dental appointment has not been scheduled. Minor attends Head Start half-day in the morning and half-day at daycare in the afternoon. CPS has not found placement for the minors. **Minors entered the shelter on July 24, 2019 / August 09, 2019 (251 days / 235 days).**

(Client #184-2020): For the one (1) year old male minor, there was one (1) visitation made this month. Visitation took place at CPS for one (1) hour. Minor was seen at *American Medical Center* for a physical and PPD on March 5, 2020. Minor returned on March 7, 2020 for PPD reading. Minor had a WIC appointment on March 12, 2020. Minor was seen at *American Medical Center* on March 16, 2020 for a follow-up appointment and doctor found the minor to have an ear infection. Doctor prescribed antibiotics and also requested to follow up on his early intervention. Minor was set to begin daycare on March 16, 2020, but due to the outbreak of COVID-19, he has not yet started. CPS has not found placement for the minor. **Minor entered the shelter on January 25, 2020 (66 days).**

(Client #186-2020): For the thirteen (13) year old female minor, there were no scheduled visitations for this month. For client services, the minor had one (1) visitation made out of three (3) scheduled visitations. CPS added a client services appointment on March 10, 2020. Client services scheduled from March 16-31st were canceled due to the outbreak of COVID-19. Minor was taken to GBHWC for intake on March 15, 2020. The minor had no medical or dental appointments this month, and no medical concerns. Dental appointment has been scheduled for April 3, 2020 for toothache. Since the minor's admission into the shelter, she has been displaying

uncooperative and irritable behaviors. CPS has found an alternative placement for the minor. **Minor entered the shelter on February 09, 2020 (52 days).**

(Client #187-2020 / #188-2020): For a set of female siblings, (6-year-old minor, and 2-year-old minor) there were three (3) visitations made out of five (5) scheduled visitations. Visitations scheduled from March 16-31st were canceled due to the outbreak of COVID-19. Minors have also received phone calls from a relative. For the six (6) year old minor, she was seen at Gentle Care Dental for a toothache on March 3, 2020. The dentist recommended that the minor's spacers be removed. Minor's follow-up appointment for March 9, 2020 was canceled. There were no medical appointments made and no medical concerns. For the two (2) year old minor, there were no dental or medical appointments made and no medical concerns.
