We are instituting guidelines to stop the spread of the virus in our establishment through proper screening, hygiene, education, as well as, engaging the involvement of clients and public health officials.

#### **MINIMUM REQUIREMENTS:**

- HEALTH CHECK SCREENING
- HAND WASHING (HAND SANITIZERS IF NO WATER AND SOAP)
- SOCIAL DISTANCING OBSERVED
- WEARING CLOTH MASK

# **Client Temperature checks:**

We will use of a touch less thermometer to check the temperature of therapist each day and of each client who enters my establishment.

**Client screening questions:** 

Ask each client entering the shop the following questions –

Have you had a cough?

Have you had a fever?

Have you been around anyone exhibiting these symptoms within the past 14 days?

Are you living with anyone who is sick or quarantined?

**Clients in establishment:** 

Clients will be allowed entry by appointment only via telephone. We will not allow customers in waiting area. All clients will wait outside the establishment and will be called by telephone to enter establishment.

# Maintain social distancing:

Spacing between persons in the establishment should be at least six feet at all times. Upon entry, client will be escorted to designated therapy room for service.

# **Use of personal protective equipment:**

Therapist and client will be required to wear masks at all times. Hand washing with soap and warm water, for a minimum of 20 seconds will be required by therapist between every client service.

#### **Disinfection:**

Establishment will be thoroughly cleaned and disinfected prior to opening daily. Disinfect all surfaces following EPA approved solutions. Wash all towels and linens daily. Therapy room will be disinfected and sanitized after every service. Wash and sanitize hands well after each service.

#### Administration:

Therapist who is sick will be expected to stay home. Training on proper sanitation, hand washing, cough and sneeze etiquette, and other protective measures.

# **Reopening Procedures**

Enhanced cleaning procedures between each appointment to deep clean suites and common areas.

Maintain sanitation and hygiene and disinfectants used meet the EPA's requirements.

Services are only by appointments to minimize social contact via phone call to avoid gathering in waiting areas.

Temperature check using no touch thermometer needs to be wiped with an alcohol wipe after each use. A fever for the purposes of this screening is ≥ 100.0°F.

Ask client if sick or haven't been around anyone that has been sick Client must wear a face mask, no entry allowed if no mask.

Client will be a one-on-one service provided in a therapy room.

The entire room is disinfected, including table, bolster, face cradle, door handles, drawer handles, stools, and light switch.

**Room will be prepared with fresh sheets** 

Massage therapist will wash hands before going to the lobby to greet client.

**Massage Session and after session:** 

- Massage therapists will wear a face mask.
- All blankets/towels will be removed from treatment rooms and have been replaced with new cleaned ones.
- Wash Hands After Massage Session
- Perform the necessary sanitation protocols by sanitizing area with appropriate solutions.
