SUBJECT: PCOR2 BUSINESS PLAN

OUR MAIN PRIORITY IS THE HEALTH SAFETY OF OUR EMPLOYEE AND PATRONS AND ALL RESIDENTS OF GUAM. WE WILL BE IMPLEMENTING THE FOLLOWING PCOR2 GUIDELINES.

- COVID 19 SAFETY NOTICE POSTERS WILL BE POSTED AT THE DOOR ENTRANCE.
- WE REQUIRE EVERYONE ENTERING OUR ESTABLISHMENT TO WEAR MASK AND SANITIZED THEIR HANDS AND THEIR PERSONAL OBJECTS; SUCH AS CELLPHONES.
- HAND SANITIZERS WILL BE AVAIBLE BY DOOR ENTRANCE AND AROUND WORK AREA AND AREAS WITH GAMES ACTIVITIES AROUND POOL TABLE AND JUKEBOX AREA. POOL STICKS AND POOL TABLE MUST BE SANITIZED OR WIPED BEFORE AND AFTER EACH USE AND AROUND JUKEBOX AND TOUCH SCREEN MUST BE SANITIZE AND WIPED BEFORE AND AFTER PLAYING MUSIC.
- GUESTS NAME AND TEMPERATURE WILL BE LOGED IN DAILY DURING PCOR 2 FOR TRACING PURPOSES.
- WE WOULD BE LIMITING NUMBER OF PEOPLE IN OUR ESTABLISHMENT TO 25% OF 50 CAPACITY; OR ONLY 12 PEOPLE INCLUDING SERVERS DURING PCOR2.
- STICKERS WILL BE POSTED TO ENSURE 6FT SOCIAL DISTANCING ARE IMPLEMENTED.
- WASH HANDS AND USE OF HANDS SANITIZERS SIGNAGE/NOTICE WILL BE POSTED WHERE ITS VISIBLE.
- EMPLOYEE (S) ARE REQUIRED TO WEAR MASK WHILE MIXING OR SERVING DRINKS TO CUSTOMERS DURING THEIR SHIFTS. OUR EMPLOYEES WILL BE TRAINED TO CLEAN AND SANITIZED COMMON AREAS AND SURFACES WHERE CUSTOMERS ARE AND THE PROPER WASHING AND SANITIZING OF BEVERAGE CONTAINERS OR GLASSES AND THE PROPER DISPOSAL OF USED DISPOSABLE PRODUCTS.
- AREAS WILL BE SANITIZED IMMEDIATELY AFTER A CUSTOMER LEAVES OUR ESTABLISHMENT.
- BATHROOMS WILL BE CLEANED AND SANITIZED EVERY HOUR AND CHECKED AMPLE SUPPLY OF TOILET TISSUES; ANTIBACTERIAL HAND SOAP; PAPER TOWELS. LEVERS/DOORS HANDLES WILL BE WIPED AND SANITIZED.
