



Alee I Catherine's Home: Women's Shelter

January 2018

During the month of January 2018, the Alee I Catherine's Home of Family Violence Domestic Assault shelter received a total of three hundred and forty-three (343) calls:

Fifteen (15) possible client referral calls from agencies, to include ten (10) self-referrals, and five (5) from VARO. Two hundred and twenty-one (221) active clients inquiring/giving information, twelve (12) past clients inquiring/giving information, thirty-four (34) calls for active clients, five (5) calls for past clients, twenty-four (24) outside agency calls inquiring/giving information, twenty-three (23) program/staff related calls, seven (7) calls for donations inquiry, and two (2) wrong numbers.

Alee I provided services for a total of ten (10) clients for the month of January; three (3) new clients, and seven (7) clients from the previous month.

Active Clients for January 2018:

Client #2360 Client entered the shelter on December 27, 2017 at 1:54pm with her five (5) minor children, ages; eight (8) months, two (2), nine (9), twelve (12), and sixteen (16) years old. Client is a thirty-nine (39) year old married Filipino woman who is a U.S. citizen. Client later brought a personal vehicle to the shelter which she utilized for transportation. Client was assisted with transportation for grocery shopping and with applying for *CCD of Block Grant* services, which client was given the application forms for. Client was assisted with applying for the *Salvation Army's Emergency Solutions Grant Program Homelessness Prevention and Rapid Re-Housing Program (ESG-HPRRP)* which client was given the application forms for. Client was not interested in applying for a protective order. Client exited the shelter and transitioned to her sister on January 05, 2018 at 1:26pm.

Client # 2360 Client entered the shelter on January 14, 2018 at 5pm. Client is a twenty-seven (27) year old single Caucasian woman who is a U.S citizen. Client was assisted with transportation services to our designated pick-up and drop-off location. Client was assisted with submitting her Public Benefits change report to the *Department of Public Health and Social Services (DPHSS)* and renewing her *Supplement Nutrition Assistance Program (SNAP)* benefits. Client was not interested in applying for a protective order. Client exited the shelter and

Alee 2 Children's Home

January 2018

For the Month of January, the shelter served a total of eleven (11) children with ages ranging from five -months (5 months) to twelve (12). Of the children, there were ten (10) Chamorro and one (1) Filipino served. Services provided included personal care, teaching life skills, transportation to school, visitations and various appointments as well as recreational activities.

Currently at the shelter, there are eleven (11) Chamorro minors and one (1) Filipino minor.

For one set of siblings, a total of eight (8) visits were made for this month and all visitations took place with the grandparents. On January 12, a counseling appointment was made for the six (6) year old female minor and the eight (8) year old male minor at *I'Famagu'on-ta* . Both minors were meeting with their designated counselor. On January 22, Alee Children's Social Worker (SW) was informed that every Wednesday, starting on the 24th, both minors will be attending *Sunshine Group Counseling* at *I'Famagu'on-ta*. For the month of January, minors attended a total

of two sessions. As per CPS caseworker S. Quinata, a court hearing is set for February 22, where they will determine further placement. SW was informed that the grandparents were actively seeking housing while awaiting their voucher through the *Family Unification Program (FUP)*. Minors entered the shelter January 1, 2017 (396 days).

For one set of siblings, a total of eight (8) visitations were made for this month and all visitations had taken place with both mother and father. On January 9, an appointment was made with the *Women, Infants, and Children Program (WIC)* for the five (5) month-old infant. SW was able to receive food vouchers, specifically for formula and infant food, to use during the next coming weeks. On January 11, *Guam Early Intervention Systems (GEIS)* representatives conducted a home visit for the five (5) month-old infant, where they assessed his wellness and development. On January 8 and 17, appointments were made with the *American Medical Clinic* for the two (2) year-old minor to receive his shots. On January 16, an appointment was made with a neurology clinic, specifically with Dr. Ramel Carlos, to conduct an electroencephalogram (EEG) on the male minor. On January 15, the two (2) year-old minor was taken to *Guam Radiology* where an x-ray of his lower body was conducted. This was needed for his appointment at *Shriners Satellite Clinic* which took place on January 18, 2018. As per the doctor from *Shriners Clinic*, the male minor will be receiving leg braces to improve leg posture and alignment of his bones. On January 8, an appointment was made to *American Medical Clinic* for the four (4) year-old minor to update her shots. Another visit was made to the clinic on January 11, due to the minor needing medical attention for her impetigo. Minors entered the shelter on October 22, 2017 (101 days).

For another set of siblings, a total nineteen (19) visitations were made for this month. All visitations took place with both mother and father. A total of thirteen (13) visitations took place at the father's residence while six (6) visitations took place at the offices of Child Protective Services. On January 5, the eldest sibling (9 year-old male) was brought to *Guam Behavioral Health and Wellness Center (GBHWC)* by his CPS Social Worker to address behavioral issues. Later that evening, Alee SW was informed that the minor will be transitioning from the children's shelter to GBHWC. Minor entered the shelter November 17, 2017 (49 days). On January 16 and 23, appointments were made with *Express Care* where the two (2) year-old sibling completed a physical and was also treated for warts. An appointment was also made for his six (6) year-old sibling so that his warts could also be treated. Minors entered the shelter on October 2 and November 22, 2017 respectively (121/71 days).

For the six (6) year old male minor, two appointments were made to *IHP Medical Group*, specifically to see Dr. Lily Perez. As per CPS caseworker R. Reyes, there are no possible placements at this time but efforts are being made for the minor to have communication with his other siblings. Minor entered the shelter on November 21, 2017 (72 days).

February 2018

For the Month of January, the shelter served a total of fifteen (15) children with ages six (6) months to thirteen (13). Of the children, there were thirteen (13) Chamorro and one (1) Filipino. Services provided included personal care, teaching life skills, transportation to school, visitations and various appointments as well as recreational activities.

On February 02. SW received a phone call from Child Protective Services (CPS) in regards to the 4-year old female minor. SW was informed that the minor would be exiting the shelter and placed with the grandmother.

On February 05 the 3-year old male minor exited the shelter and placed with his grandmother.

On February 26 two (2) male minors, ages eleven (11) and Thirteen (13) exited the shelter and transitioned to Sanctuary Inc.

Currently at the shelter, there are twelve (12) Chamorro minors.

For one set of siblings, a total of eight (8) visits were made for this month and all visitations took place with the grandparents. For the 6 (six) year old female minor as well as the 8 (eight) year old male minor, a total of two (2) individual counseling sessions with *I'Famagu'on-ta*. Both minors also attended three (3) *Sunshine Group Counseling* sessions. On February 06, all three (3) minors had an appointment at *Seventh Day Adventist* where a physical was done. On February 09, all three (3) minors had a follow up appointment at the same clinic where labs were completed. On February 22, a court hearing was held to determine further placement for the minors. While awaiting their voucher through the *Family Unification Program (FUP)*, it was suggested by the CPS caseworker that the grandparents identify temporary housing. As per the judge, it is granted that funds from a separate source, Social Security, would be used to pay for the temporary housing unit until the voucher steps in. Once the funds are appropriated, the minors will transition out of the shelter and with the grandparents. Minors entered the shelter January 1, 2017 (424 days).

For one set of siblings, a total of eight (8) visitations were made for this month and all visitations took place with both mother and father. On February 15 and 27, *Guam Early Intervention Systems (GEIS)* representatives conducted a home visit for the 6-month-old infant.

A total of six (6) visitations took place at the father's residence while ten (10) visitations took place at Child Protective Services. On February 03, the six (6) year old minor was taken to *Express Care* to treat warts that appeared on his body. Minor was given treatment. Minors entered the shelter on October 02 and November 22, 2017 (149/99 days).

For the six (6) year old male minor, a total of three (3) visitations were made for this month. All visitations had taken place at Paseo Park with his other siblings. A total of two (2) appointments were made to *Harmon Loop Dental* where a checkup and cleaning were done for the minor. Minor entered the shelter on November 21, 2017 (100 days).

For the Month of March, the shelter served a total of fifteen (15) children with ages ranging from seven months (7 months) to twelve (12). Of the children, there were eleven (11) Chamorro, two (2) Filipino, and two (2) Chuukese. Services provided included personal care, teaching life skills, transportation to/from school, visitations and various appointments as well as recreational activities.

On March 02, SW received a phone call from Child Protective Services (CPS) in regards to the 7-year old female minor. SW was informed that the minor would be transitioning back to her foster parents.

On March 07, SW received a phone call from CPS in regards to two (2) male minors, ages three (3) and thirteen (13). SW was informed that the minors would be exiting the shelter and placed into foster homes.

SW was informed that the seven (7) year old minor would be transitioning out of the shelter and back with his mother. The ten (10) year old male transitioned out of the shelter and into a foster home.

Currently at the shelter there are ten (10) Chamorro Minors and one (1) Chuukese Minor:

For one set of siblings, a total of nine (9) visits were made for this month and all visitations took place with the grandparents. For the six (6) year old female minor and eight (8) year old male minor, a total of four (4) individual counseling sessions were attended at *I'Famagu'on-ta*. Both minors also attended two (2) *Sunshine Group Counseling* sessions. On March 09 and March 19, all three (3) minors had an appointment at *Hafa Adai Family Dental Clinic* where dental treatment was given. On March 29, a court hearing was held to determine further placement for the minors. While awaiting their voucher through the *Family Unification Program (FUP)*, it was suggested by the CPS caseworker that the grandparents identify temporary housing. Two (2) units were identified by the grandmother, but due to circumstances they were unable to obtain it. The CPS Caseworker as well as the grandmother are currently seeking other housing options. Minors entered the shelter January 1, 2017 (455 days).

For one set of siblings, a total of nine (9) visitations were made for this month. Four visitations had taken place for all minors (4yrs, 2yrs, & 7 months) with both mother and father. The other five visitations had taken place at *Client Services* for the 4-year old female with her biological father. On March 22, *Guam Early Intervention Systems (GEIS)* representatives conducted a home visit for the two (2) year old minor where they assessed his wellness and development. Minors entered the shelter on October 22, 2017 (160 days).

For another set of siblings, a total six (6) visitations were made for this month. Four (4) visitations had taken place for all siblings (7yrs female, 6yrs male, & 2yrs male) with both mother and father at CPS. Two (2) visitations had taken place, but only for the six (6) year old male minor and the seven (7) year old female minor with their biological father. Minors entered the shelter on October 02, November 22, and March 22 (180/130/9 days).

For the six (6) year old male minor, a total of six (6) visitations were made for this month. Three (3) visitations had taken place at CPS with his other siblings and the other three (3) visitations were made with a potential foster family. A total of three (3) counseling sessions were made for


