Apply the recommended industry guidelines to include the following:

Guest(s):

• Facial mask is mandatory, No Mask No Entry. Mask will be required throughout the tour except in water.

- Guest will not be allowed to enter company vehicles if they are showing symptoms of covid-19 such as fever, coughing & difficulty breathing.
- Company vehicles will be cleaned and sanitized before and after each trip.
- Seating spacing to meet social distancing standard. Seperate different parties by an empty row.
- Guest will be required to use hand sanitizer provided or hand washing stations frequently.
- After arrival to our beach location, guest will be required to wear mask and sanitize hands upon entering premises.
- Covid 19 signage will be posted at the premises .
- Signage will also be posted in restroom area to include handwashing procedures.
- Guest will be asked to follow taped off points on floor or other indicators to follow social distancing protocol. And be mindful of other guests and please keep up with your group.

Employees:

- Driver will be trained to check guest(s) temperature with non-contact thermometer.
- Employees will wear face mask.
- Employees will be required to notify supervisor if they are feeling sick(fever, cough, difficulty breathing). Also, if employee has a family member at home with Covid 19, she/he will notify supervisor.

- Employees will be educated about Covid-19 prevention, this includes appropriate and frequent hand hygiene practices, respiratory hygiene, mask use, and symptoms of covid-19.
- Sanitize hands after clocking in and prioritize frequent proper handwashing.
- Avoid sharing personal objects.
- Frequently touched surfaces will be cleaned and disinfected at least daily, or as much as possible required by safety requirements.
- We will encourage use of touchless payment options as much as possible, if available.
- Employees will practice social distancing of 6 feet at all times with exception of work tasks that cannot be mitigated to ensure proper distancing.
- Employees are responsible to keep their workstation neat and clean and to sanitize using disinfectant cleaner.
- Employees are required to keep all equipment such as but not limited to jet skis, like jackets, and other equipment guest will be using sanitized before and after use
- Regular cleaning and disinfecting schedule for daily operations will be created, toilet facilities and handwashing sinks will be thoroughly cleaned and sanitized once in every hour of operations.

<u>Activities</u>

- Capacity and group size base on guidance issued by local authorities will operate at 50% of capacity.
- Jetski, kayak, screamer, fly board and Segway will be single ride with an exception if there is a child/minor involved, guardian will accompany child. Banana boat will be 3 person maximum
- All equipments used will be sanitized before and after each use.

The following will be temporarily closed:

Play room, water dispenser, welcome pictures, food and drink services, beach ball, free rental snorkel masks and locker rooms.
