

We opened October 12, 2020 Monday. Our hours of operation for the month of October 2020 is 8:00am – 6:00pm.

We maintain the capacity of staff to children required by regulations to ensure safety.

Staff and children (2yrs above) wear face masks within the facility and the babies are separated from children under age of two because of the danger of suffocation.

Procedures on how we accept the children with parents

- Hand hygiene we set up of the entrance of the facility, we provide hand sanitizer can clean their hands before they enter.
- We Limiting parents and visitors onto the premises of the facility
- Our Childcare providers (teachers) are to greet children outside the facility as they arrive and escort them inside. We Screen our children upon arrival, we take children temperature before they enter to the facility.
- We ask our parents/guardian to confirm that the child does not have fever, cough, and shortness of breath. Ask our parents/guardian about last night if they have fever, cough, shortness of breath and how family is.
- We ask our children to take off outside shoes to indoor shoes.

Employee's health and hygiene.

- We Screen all our employees reporting to work. Employees with symptoms are not permitted to work.
- Our Employees Provide and wear face mask within the facility we take temperature to confirm does not have fever, cough, and shortness of breath.
- We change our outside shoes to indoor shoes for safety.
- We training our employees on enhanced disinfection and proper PPE (personal protection equipment)

Implement social distancing

- Our nap time, we ensure that our children's nap mat are spaced 6feet apart.
- Our classroom same group each day and at the same time same teachers.
- We separate our age group each class.
- We prepare our special activities art and craft, music, dancing, read a stories and using their own materials.

Intensify cleaning sanitization and disinfection

- We sanitize our chair , high chair , table, doorknobs ,toys , light switches, classroom, restroom, sink handles, nap mats , nap pads toilet bowl (every time use),cubbies mop the floor sanitize the counter, vacuum.

- Our toys that cannot be cleaned and sanitized are prohibited for use.
- Cloth toys are prohibited
- We provide container for each children to use for activity to play. Set aside toys that need to be cleaned and sanitized we make sure we separate container level (sanitized /used).
- We make sure we have enough toys so that the toys can be rotated through cleanings.

Clean and Disinfect bedding

- Our children use only their own sleeping bags, blanket, and pillow. And stored individually labeled. We send home their own belongings to be cleaned and sanitized weekly.

Diapering

- We provide each children a changing pads to use and sanitized every time we use. We follow the CDC guidance for diapering.

Washing Feeding or Holding a child

- Contaminated clothes are to be placed in a plastic bag and send home.
- Our children have extra cloths inside their bag
- We wash our hands before and after handling our baby's infant bottle.
- Used Feeding bottle we placed in individually plastic and send home to cleaned and sanitized.

Food preparation and meal service

- We wash our hands before preparing food and after helping children to eat.
- We serve our children meals in the kitchen, classroom are spaced 6feet apart.
- Our children wash their hands before and after they eat.

As of now October 12,2020 we will follow the capacity of staff to children required by regulations to ensure safety.
