Payment Methodology: Guam Medicaid will amend the State Plan payment methodology for SNF from payment based on RUG score to a Per Diem based payment to start in 1st Quarter FY2021 (October 2020). The beginning Per Diem rate is calculated

FY2021 Starting Per Diem

- 1. A base Per Diem rate is calculated by using the Guam Medicaid data to determine Total Medicaid payment amounts made to GMH SNF for FY2019 based on RUG score. This total amount is then divided by the LOS total days paid for that total FY19 amount for that fiscal year to get a daily Per Diem rate.
- 2. An adjustment is then calculated using an inflation factor for two year trending from ffy 2019 to ffy 2021 from the CMS Market Basket Index Projection Table to determine a comparable Per Diem Rate for FY2021 considering inflation. This amount is the FY2021 Starting Per Diem Rate.

3. The Per Diem rate thereafter will be calculated at the beginning of each fiscal year using the previous year's per diem and then adjusting by an inflation factor for the one (1) previous year trending forward to the current fiscal year(i.e. ffy 2021 to ffy 2022) The inflation factor will be derived from the CMS Market Basket Index Projection Table to determine a comparable Per Diem Rate for the current fiscal year starting.

FY2021 Per Diem Rate = Previous FY GU Medicaid GMH SNF Total Payments
