CHURCH FACILITY MITIGATION PLAN DURING PCOR1 COVID-19 PANDEMIC

A. General Restrictions and Requirements

- Worship services and other religious ceremonies occurring indoors are limited to no more than 25% of the facility's occupancy load (20 pax out of 80).
- Outdoor worship services and other religious ceremonies may be covered to protect from the elements but not be enclosed. Each cluster of seats must come from the same household and not to exceed six (6) and at least six feet away from other seats. All in attendance must be wearing face masks and maintaining six feet physical distancing.
- Attendees who do not live in the same household must maintain a physical distance of at least 6 feet. Social distancing must be enforced in all types of ceremonies and/or gatherings.
- Physical distancing guides, such as tape on floors or walkways and signs on walls, will be placed to ensure that staff, congregants, and visitors remain at least 6 feet apart in lines and at other times.
- Prior to the start and at the conclusion of the service, the facility will be thoroughly cleaned and disinfected using disinfectant cleaning supplies according to CDC guidelines.
- If multiple services are offered, schedule services far enough apart to allow time for cleaning and disinfecting of high-touch surfaces between services.
- Disinfect microphones and stands, music stands, instruments, and other items on pulpits and podiums between each service.
- Post readily visible signage at the entrance and throughout the facility to remind staff and congregants of the need to wear face masks, social distance, follow respiratory and hand hygiene, and prohibit entry of individuals with COVID-19 symptoms.
- Staff, congregants, and visitors must wear face masks at all times. Such masks must cover both the mouth and the nose as specified by U.S. Centers for Disease Control and Prevention (CDC) guidelines. <https://www.cdc.gov/coronavirus/2019-ncov/prevent-getting-sick/cloth-face-cover-guidance.html>
- Whenever possible, prohibit the sharing of commonly used objects, such as religious aids and microphones.
- Musicians will maintain at least 6-foot physical distancing with masks on. Singers and Speakers must use a microphone and maintain greater physical distance of at least 12 feet from the


congregation. Preferably, Musicians and Singers from the same household will be scheduled to lead worship together.

- Prohibit physical contact with persons outside of your household unless medically necessary.
- Sanitized offering baskets will remain at the altar where individuals may drop in their offerings. Online giving will be available and encouraged as a safer option.
- Prop or hold doors open during peak periods when congregants are entering and exiting facilities, if possible, and in accordance with security and safety protocols,

B. Healthy Hygiene Practices

- Staff will wash their hands with soap and water for 20 seconds before and after the service.
- Prior to entering the facility, congregants use hand-gel sanitizer with at least 60% alcohol.
- Provide and maintain personal protective equipment for staff to perform enhanced cleaning/disinfection.

The Redeemed Christian Church of God, Maranatha Chapel mitigation plans have been drafted to adhere to CDC health and safety guidelines.
