OUR MAIN PRIORITY IS THE HEALTH SAFETY OF OUR EMPLOYEE AND PATRONS AND ALL RESIDENTS OF GUAM. WE WILL BE IMPLEMENTING THE FOLLOWING PCOR3 GUIDELINES.

- COVID 19 SAFETY NOTICE POSTERS WILL BE POSTED AT THE DOOR ENTRANCE.
- WE REQUIRE EVERYONE ENTERING OUR ESTABLISHMENT TO WEAR MASK AND SANITIZE THEIR HANDS AND THEIR PERSONAL OBJECTS; SUCH AS CELLPHONES, ETC..
- HAND SANITIZERS WILL BE AVAILABLE BY DOOR ENTRANCE AND AROUND WORK AREA AND AREAS WITH GAMES ACTIVITIES AROUND POOL TABLE AND JUKEBOX AREA. POOL STICKS AND POOL TABLE MUST BE SANITIZED OR WIPED ON/OR BEFORE AND AFTER EACH USE AND AROUND JUKEBOX AND TOUCH SCREEN MUST BE SANITIZED AND WIPED BEFORE AND AFTER PLAYING MUSIC. WE RECOMMEND TO OUR PATRONS TO DOWNLOAD THE JUKEBOX APP ON THEIR CELLPHONE AND PLAY MUSIC REMOTELY.
- POOL TABLE LOG SHEET IS PROVIDED TO LIST EACH PLAYER'S NAME AND ONLY LIMITED TO TWO (2) PLAYERS AT A TIME.
- GUESTS NAME AND TEMPERATURE CHECK AT THE ENTRANCE. LOG BOOK WILL BE MAINTAINED FOR CONTACT TRACING PURPOSES AND WILL BE KEPT ON FILE FOR 3-4 MONTHS OR LONGER.
- REQUIRED TO WEAR FACE MASK AT ALL TIMES WHEN NOT CONSUMING FOOD OR DRINKING. CUSTOMERS ARE REQUIRED TO WEAR MASK WHILE SPEAKING TO OUR SERVERS.
- WE WOULD BE LIMITING NUMBER OF PEOPLE IN OUR ESTABLISHMENT TO 50% OF 50 CAPACITY; OR ONLY 25 PEOPLE INCLUDING SERVERS DURING PCOR3.
- LIMITED INDOOR SEATING WITH 6FT DISTANCE BETWEEN EACH PARTY
- NO LIVE ENTERTAINMENT, NO KARAOKE AND NO DANCING IN OUR ESTABLISHMENT.
- NO TABLE MENUS. WE DON'T COOK OR SERVE HOT MENU ITEMS. CHASERS ARE SERVED INDIVIDUALLY AND OR PREPACKAGED AND SERVED TO CUSTOMER. CUSTOMERS ARE NOT ALLOWED TO GET THEIR OWN FOOD.
- NO TABLE PRESETS, SUCH AS NAPKINS, STRAWS, ETC., WHICH ARE ONLY UPON REQUEST AND GIVEN TO THE INDIVIDUAL REQUESTING.

- STICKERS WILL BE POSTED TO ENSURE 6FT SOCIAL DISTANCING ARE IMPLEMENTED.
- WASH HANDS AND USE OF HANDS SANITIZERS SIGNAGE/NOTICE WILL BE POSTED WHERE ITS VISIBLE.
- BARTENDER(S) ARE REQUIRED TO WEAR MASK WHILE MIXING OR SERVING DRINKS TO CUSTOMERS DURING THEIR SHIFTS. OUR EMPLOYEES ARE TRAINED TO CLEAN AND SANITIZED COMMON AREAS AND SURFACES WHERE CUSTOMER'S ARE AT AND TRAINED THE PROPER WASHING AND SANITIZING OF BEVERAGE CONTAINERS OR GLASSES AND THE PROPER DISPOSAL OF USED DISPOSABLE PRODUCTS.
- WE ARE LIMITING OUR HOURS TO OPERATE ONLY FROM 05:00 PM TO 10:00PM OR NO LATER THAN 12 MIDNIGHT. ONLY ONE SERVER ALLOWED BEHIND THE BAR DURING THE MENTIONED HOURS. ONE MANAGER ASSIGNED TO MAIN FLOOR AND MONITOR IN COMING CUSTOMERS AND TO IMPLEMENT GUIDELINES.
- AREAS WILL BE SANITIZED IMMEDIATELY AFTER A CUSTOMER LEAVES OUR ESTABLISHMENT.
- BATHROOMS WILL BE CLEANED AND SANITIZED EVERY HOUR AND CHECKED AMPLE SUPPLY OF TOILET TISSUES; ANTIBACTERIAL HAND SOAP; PAPER TOWELS. LEVER/DOOR HANDLES WILL BE WIPED AND SANITIZED. BATHROOM LOG SHEET IS POSTED BY THE BATHROOMS ENTRANCE.
- THERE ARE TWO (2) VENTILATIONS, AIR PURIFIERS TO COVER 900~1000 SQFT AREA AND IT'S MAINTAINED AND CHANGED OUT HEPA FILTERS + CHARCOAL FILTER EVERY 3 MONTHS OR AS NEEDED PER MANUFACTURERS RECOMMENDATION.
- TRAINING OUR STAFF HOW TO REPORT IMMEDIATELY AND FOLLOW PROTOCOL PROCEDURES AND HOW TO CONTACT PROPER AUTHORITY FOR SAFETY ACTIONS.
