

OPERATION PLANS FOR COVID-19: TAKEOUT and PATIO dining only *updated October 20, 2020 in accordance to DPHSS Guidance Memo 2020-41

HOURS OF OPERATION

Thursday, Sunday, Monday: 3-9pm Friday, Saturday: 3-10pm Takeout with 3 patio tables

EMPLOYEE HEALTH

- Employees must immediately report symptoms to manager on duty as per their Employee/Employer Covid-19 Agreement.
- All employees must wear their face mask to complete his or her duties.
- Employees who are showing COVID-19 like symptoms, or who have been in close contact with persons exhibiting symptoms, or who have tested positive themselves are required to inform the manager on duty and stay home. A return to work would be based on negative test results and/or professional medical advice/clearance.
- Employees who have recently had a close contact with a person with COVID-19 are also asked to stay home and monitor their health. Employee must then present a negative test result and or provide medical clearance and be in good health in order to return to work.
- Frequent handwashing with soap and water for at least 20 seconds.

SANITATION

- All high contact surfaces are sanitized every 15-30 minutes.
- Full cleaning/sanitation wipe down every 4 hours or every shift change, whichever comes first.
- Areas of concentration include:
 - -Entrance/Patio-Podium-Patio Counter-Door handles-Pens, credit card machines-Patio Chairs-Bar counter-Restrooms-Publicly posted menus

GUEST SERVICE

- Masks are required for service and any time in communication with staff.
- Signage posted at entrance to remind guests of new policies and procedures.
- Guests and staff to maintain a social distancing of 6ft at all times possible.
- Three tables are available for outside dining, not to exceed 5 guests at one time.

- Tables are socially distanced 6 ft apart with stanchions surrounding to safeguard guests.
- Guests are only permitted entry strictly for restroom use only.
- Temperature checks will be done for every person entering establishment and dining outside. Any temperatures above 100F will not be allowed entry or service.
- Any persons who are sick or exhibiting any symptoms are not allowed entry.

DINING TABLES

- Guest tables are sanitized prior to use. This includes table tops, sides, and chair surfaces. The same surfaces are cleansed following each tables use.
- Tables are set upon guest arrival to ensure cleanliness.
- Shared condiments shall not be allowed at any table. All condiments shall be poured into single use containers.

ORDER/PICKUP

- All takeout interactions are done outside the premises. Guests are not permitted to enter as per the establishment except for restroom use.
- Curbside pickup is ideal. Upon ordering, guests are asked their vehicle model so staff can assist them without the guest leaving their vehicle.
- Guests are encouraged to use the QR app to view the menu on their personal devices.
- Single use paper menus are also available.
- Pens offered to guests are sanitized after every use.
